### **PUBLIC COMMENT**

Charles Evans, 34 Goosetown Road, questioned why the re-assessments went "sky high". Mr. Evans said he was left a note from the Tax Assessor to schedule an appointment. He attempted to contact her three times and never received a call back. He said the assessor has never been able to enter the Evans' home but his assessment increased \$76,000.00 this year. Mayor Holt attempted to explain that the Mayor and Council have nothing to do with the assessments and "that there is zero tax increase from this Council, however costs have gone up". Mayor Holt will reach out to the assessor to contact Mr. Evans.

Mrs. Kovach stated that she reached out to the Hunterdon County Tax Board and asked for someone to attend a Council meeting for a Question and Answer Session on assessments. Mayor Holt also spoke to the County Tax Board and will reach out again to arrange a meeting before April 1<sup>st</sup> when tax appeals are due.

John Rinald, 30 Goosetown Road, asked what is the Town doing to decrease taxes for the residents? Mayor Holt explained that there are three vacant pieces of land and two pieces that have already received zoning approval, they are the hotel on Route 31 and two office buildings owned by Fallone Properties. The three vacant pieces are on Old Highway 22 across from STS, the Moebus Tract and the Industrial Tract located near the Wastewater Treatment Plant. In addition to these sites, an office building is approved next to the Hunterdon County Library on Halstead Street and the Zirinsky Tract, located below Union Gap Village. This is approved for residential condos and town houses.

Councilwoman Schaumburg asked if the Town has a Industrial Development Committee and suggested an Economic Development Committee to study the locations and make recommendations to Mayor and Council and the Planning Board. The Master Plan Committee is expected to have the re-examination done in 2005.

Robert Ragozine, 24 Haver Farm Road, was happy to see that the Town voted to hire a new auditor at a savings but questioned why three Council members voted to keep the current professional at a higher rate. Mr. Ragozine questioned why the current auditor dropped his rate after Requests for Proposal went out? Mayor Holt explained Mr. Colantano has been with the Town for 25 years and wanted to keep the account. Mr. Ragozine also questioned how the current auditors rate was lowered so significantly and came within \$25.00 of another firm? "What a coincidence" suggested Mr. Ragozine.
