# **PUBLIC COMMENT**

Erika Huston, 12 Union Road, wished to address the proposed sidewalk to be laid on Union Road. Mr. Ragozine said there will be an opportunity to address that at the time of the introduction to Ordinance 08-05, later in the meeting.

Joe Procopio, Jr., 14 Busher Place, announced that Councilman Rob Ragozine is an excellent coach!!

Gary Hayes, of 12 East Main Street, Dovetales Fine Heritage Furniture, asked Council to address the crosswalk on the corner of Leigh Street and Main Street. Mr. Hayes commented on an incident he had while crossing at the corner and a school bus not stopping for him. Mr. Hayes asked to see Policemen standing at the corner monitoring the walk and not sitting in patrol cars. He also said that was a reason shoppers do not cross over to East Main for the stores.

Kathy Olsen, Chief Finance Officer, is attempting to determine what the county needs to release funds to requesting municipalities. Items pertaining to the Master Plan are part of the required documents. Attorney Cushing suggested Planner, Beth McManus, contact the County Planning Board to find out what items are on the checklist for the Town to get their money.

### RESOLUTION #70-08 – DEFEATED HIGH SCHOOL BUDGET

Mr. Shea reported on his attendance at the School Board meetings discussing the defeated budget. Mayors and representatives from municipalities sending districts attended and discussed the amounts of cuts necessary to be made. The High School makes the determination of where the cuts will be made. Attached is a Resolution outlining the cuts to the 2008 - 2009 budget. #### INTRODUCTION OF ORDINANCE # 08-05 – CAPITAL ORDINANCE

Mr. Cutter gave an overview for the intended use of the proposed capital ordinance. The funds are to be used for sidewalk improvements, namely, construction and installation of a sidewalk on Union Road. The Road Committee met with the three (3) affected neighbors, Thad and Erika Huston, John and Helen Leonard, Lee and Anne Ezawa. The residents also submitted letters in opposition to the proposed sidewalk. Their main issues were liability and clearing the sidewalks of snow and ice. The public was allowed to comment. Erika Huston, 12 Union Road, expressed her strong opposition to the project and stated that she felt it was extremely unfair that her "insurance would go up" and that her land was being taken from her. She stated clearly "We do not want it".

Mr. Connell, 18 Messig Road, stated that that stretch is very dangerous for pedestrians from speeders on Union Road, he suggested adding a speed bump to the area.

Mr. Kurtiak, stated he is in full support of the sidewalk, and said that part of Union Road is the "missing link" and that it is a public safety enhancement.

Mr. Pendergast, 20 Spruce Run Road, said "it's not that big of a deal to take care of the sidewalk". He has been doing it for years.

Mr. Procopio, 14 Busher Place, said he can sympathize with the resident that they will loose a little land, but, ultimately, it is a safety issue and this is a walking community. Mr. Kurtiak asked about reviewing the plans. Mr. Cutter said they are on file in his office and anyone wishing to review them should just call him. Mr. Cutter explained that there will be a little narrowing on the road, which may help slow the traffic as a result. Councilman Shea said his concern was to assist the residents in having the sidewalk cleared and that he and the Mayor have begun an outreach program for the seniors or anyone needing assistance. Two young boys have already agreed to help and names will be available in the clerk's office.

Councilwoman Insel said the Town was not looking to take property, however, it is being done for safety reasons.

A motion was made by Mrs. Insel, seconded by Mr. Pender to introduce Ordinance #08-05 on first reading as submitted:
