MAYOR'S COMMENTS

1. Mayor Schaumburg announced she will be attending the New Jersey Association of Counties Conference on Wednesday night. The Mayor said she will have her voice heard, but first, son, Garrett, is in the World Series and she will be attending that!!

COUNCIL TERMS

Mayor Schaumburg once again explained the mayor's term increased to four years which was imposed by the New Jersey State Legislature in 2005. Council terms were also

Mary Jo Kurtiak, 5 Busher Place, expressed her support of the sidewalk on Union Road. Mrs. Kurtiak, an early morning jogger, is concerned with children and adult safety and would "love to see a sidewalk".

Erika Huston, 12 Union Road, once again stated opposition to the sidewalk and presented council with a petition of 51 signatures of residents she said were not aware of the cost of the proposed sidewalk. Petition was accepted.

Mr. Cutter reported that the Road Committee and Town Engineer, Robert Clerico, met for a second meeting with the three residents affected by the sidewalk, the Huston's, the Ezawa's and the Leonard's at the request of Mrs. Huston.

Brandon Mc Isaac, 8 Busher Place, father of a young child, said he is ultimately in favor of the sidewalk and views it as a proactive approach to safety.

Dave Kurtiak, 5 Busher Place, acknowledged the Town's obligation to ensuring a safe route to school for children for residents in general. Mr. Kurtiak asked about the obligation of courtesy busing to school and the costs that would surpass the \$75,000.00 for the sidewalk.

Mayor Schaumburg stated concerns about people cutting through private properties, Marudy Drive down to West Main Street, as an insurance liability and that crimes were reported on the path way. Crossing guards would complain of older children coming down the path and not stopping at the bottom of the hill, running across the roadway. It is "not safe" and kids should not be walking without a sidewalk. The Community Vision Study that was completed last year, where engineering professionals labeled that stretch without sidewalk as the "missing link", recommended the sidewalk be completed. The circulation study that was completed by Orth Rodgers, was completed at no cost to the town. The Department of Transportation paid for the traffic study for the entire Town with grant money.
