- Neon signs will not be allowed in the Historic District
- There will be no color restrictions
- Size of sign will not be larger than 10 x 24
- Fees will be reduced for applications before the Board of Adjustment to \$75.00
- The Sign Committee will be a sub-committee, or arm of the Board of Adjustment, rather than an independent body. There will be no escrow required for sign variances not relating to a site plan or a subdivision.
