From the Mayor's Desk...

Matthew Holt



On January 1 of every year, those of us in Clinton Municipal Government gather together to re-organize the Town, and to prepare for what is our busiest time of the year.

It is hard to believe that I have been serving the community as a member of the governing body for 10 years, and have entered my second year as your Mayor. I would like to thank Ray Bahto for his service to the Town, and to welcome our newest member of the Council, Christine Schaumburg.

I look forward to the upcoming year, the many ongoing projects we have in front of us, presenting a well thought out budget to our community, and to being allowed to continue to serve the Town of Clinton to the best of my ability.

We spend approximately 4 months of every year working on our budget. This process starts in November/December in our various committees, and finishes with several public work sessions and finally the budget introduction at some point in late February or early March. This is a process we have used for many years.

Our job, while difficult at times, is in theory, fairly straight forward. We must determine annually how to control the daily operating costs of the Town, and then add capital projects we wish to accomplish to

keep the infrastructure of the Town in the best shape possible. This creates the "spending" side of the equation which is then coupled with the anticipated revenue side (assessed values), to arrive at the annual tax rate.

During a recent Council meeting, several residents came in to ask questions about our budget process, and how it affects their individual tax bills. As was clarified at that meeting, the governing body of the Town has control of only approximately 20% of the total tax levy that we all are assessed annually. While the Town is the collection agent for the total amount of your bill, approximately 80% is simply sent on to our school systems, and the County of Hunterdon, who have their own annual budget process.

On February 10th, 2005, after over a decade of working on potential solutions, I proposed to the Council my plan to bring our 47 Leigh Street building project to a successful completion. This plan will be moved into our Buildings and Grounds Committee to put finishing touches on it, and then presented to Council for approval.

This property was wisely purchased by the municipality many years ago; in anticipation of the need for the land once the Leigh Street Bridge was rebuilt by the County. I look forward to seeing the transformation in this building, and the improvement to the street-scape.

Enjoy the balance of the winter.

Department of Fire Prevention by Jack Daniels



Do you know how to tell if there is carbon monoxide in your home?

Do you know what carbon monoxide is? It is a poisonous gas that is colorless and odorless. It is produced when any carbon-based fuel is burned. One of the byproducts of this burning is carbon monoxide. Your senses alone will never be able to detect if you are breathing in carbon monoxide.

Carbon Monoxide detectors are required in any residential dwelling that has any fuel fired appliance or an attached garage. I can personally vouch for the necessity of these devices. My daughter and her family are alive today as a result of a battery operated carbon monoxide detector. This device activated recently and continued to go off intermittently. Upon checking the gas fired water heater and furnace, I discovered that both appliances were not venting into the chimney at all. Further inspection revealed that the inside chimney liner had crumbled and turned to dust. This material dropped to the lower part of the chimney and entirely blocked off the chimney vent opening. Carbon monoxide had been pumping into the basement and the rest of the house for at least 12 hours, probably more. They are all so lucky to be alive. Had they went to sleep that night, I am certain they all would have stayed asleep.

Install your own carbon monoxide detector today. If you already have one, make sure it is working properly. Correct placement of these devices can be found in the installation instructions that came with the device. More than one device may be required to provide adequate coverage. Spring and Summer fire safety tips to remember all year:

The outdoor cooking season using barbecue grills is upon us once again. Remember to use these types of cooking appliances in a safe manner. Maintain at least a 5-foot distance to the side of any building with these appliances whether in use or not. These barbecues give off enough heat to dry combustible materials out much quicker. Once these products become too dry they can ignite easily with just a little heat from a grill.

When the time changes in April, please remember to change your battery in your smoke detectors. Smoke detectors and carbon monoxide devices should be tested and cleaned regularly. Cleaning can be accomplished with a quick swipe of a vacuum cleaner hose. This will help the device to last longer too.

REMINDER: A Certificate of Smoke Detector/Carbon Monoxide Alarm Compliance is required for the change of tenancy or ownership in all homes and rentals. The

Business Owners:

The purpose of the State of New Jersey Uniform Fire Code(UFC) is to verify and maintain a minimum level of fire safety. This entails an inspection of your business to verify fire safety compliance. This inspection is conducted once a year and if any violations are discovered, subsequent re-inspections are conducted. Please remember that any violations of the UFC are required to be corrected within the time listed on the violation notice. If the time frame cannot be met, then a Request for an Extension of Time is required to be filed and approved. This form and other forms may be downloaded from the Town's new website <http://www.clintonnj.gov>

Frequent fire code violations are use of extensions cords, non-working exit and emergency lights and lack of inspections for fire extinguishers or kitchen hood systems. Please make sure these items are satisfied within your business.

TRASH:

Trash Receptacles: Please take all necessary steps to keep your trash dry.

No garbage shall be put out for collection more than 12 hours prior to 12:01 a.m. of the day of regular garbage collection.

No person shall place any garbage, litter, refuse, rubbish or other materials put out for collection on any public street, road, thoroughfare, lane or alley of the Town of Clinton or in such a way so as to block any public sidewalk or other public right-of-way.

SNOW:

The owner, occupant or tenant of premises abutting or bordering on any street in the town shall remove all snow and ice from the abutting sidewalks of the street or the abutting right-of-way actually used by the public, or in the event of

daylight after the snow falls or the ice forms thereon.

No owner, tenant or occupant of premises abutting on a street shall deposit snow or ice on any street, it being the intent and purpose to prohibit all persons from depositing snow and ice which accumulates within the private property belonging to that person on the sidewalks or streets of the Town.

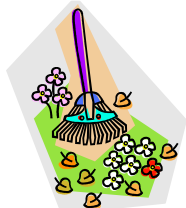
BRUSH / YARD DEBRIS:

END OF WINTER REMINDERS



Even though the days are getting longer and the weather a bit warmer, wintry weather is still a possibility. Please don't forget that Overnight

Parking Restrictions for Snow Removal remain in effect until April 1st - if you have overnight guests or other special circumstances which require additional on-street parking please notify the police department AHEAD OF TIME so that arrangements can be made. Also, please remember that all sidewalks must be cleaned of snow or frozen precipitation within 12 hours of daylight after the precipitation ceases to fall - if you have special needs or are

unable to clean your sidewalks as required, please notify the police department AHEAD OF TIME so that we can assist you if at all possible.

TOP TEN SPRING SAFETY TIPS:

1. Use designated crosswalks.
2. Look both ways before crossing streets.
3. Wear light or reflective clothing while walking at night.
4. Never "ASSUME" that a car sees you walking along or crossing a street.
5. Kids - report any suspicious activity or behavior to your parents or a teacher.
6. Parents - make sure you know where your children are going, who they are with, and when

they will be back.

7. Always wear a helmet while riding a bike, skateboard, scooter or roller blades.
8. If it is being operated on a public street and it is powered by any means other than "human-power", it is required to be registered, insured, and its operator must be licensed.
9. While being operated on a public street, bicyclists, skateboards, roller blades and other "human-powered" devices MUST obey all traffic laws and should ask themselves, "If a police officer were watching me right now would I be doing this?".
10. Use common sense, and if in doubt - ask someone.

~ Councilwoman Garber announced the addition of Kathy Sullivan to the Newsletter committee.

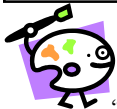
~ The Annual Town of Clinton Fishing Derby will be held at DeMott Pond on Saturday, April 30th.

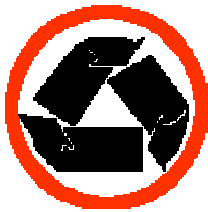
