The holiday season is fast approaching and again I want to remind everyone to support our local merchants who help make Clinton the wonderful Town it is!

I am proud of the many accomplishments of our Town in 2007. Most recently, we received the Clean Water New Jersey Award for Local Public Education from the New Jersey Department of Environmental Protection. I want to thank our Administrator, Bob Cutter, for his excellent work to create our Stormwater Management Plan and our Water Collector, Nancy Burgess, for helping to create our education materials.

The Hunterdon County Freeholders and the Hunterdon County Planning Board also recognized Clinton in four categories. Congratulations to Fox Lumber for the award they received for the historic renovation of the train station and other buildings on their property. Special recognition was given to our historic renovation of 47 Leigh Street as well. Our Finance Department, Zoning Office, Water and Sewer offices and our Historic Commission now occupy this building. As a result, the Clinton Police Department now has space within our municipal building for much needed expansion.

The Town's green initiatives including an expanded recycling program, green cleaning products and replacement of a municipal vehicle with a hybrid, received recognition as well. These initiatives are environmentally friendly while saving tax dollars. In 2008, we will focus on energy saving initiatives for our Water and Sewer Departments.

Finally, the Town of Clinton received the first Freeholders Partnership Award for our Vision Study. This truly was a joint effort by our Smart Growth Committee, our Planner, Carl Hintz, the Regional Plan Association, and most importantly, Clinton residents

and business owners. The New Jersey Office of Smart Growth, the Hunterdon County Open Space Trust and the New Jersey Department of Transportation funded this effort and participated in the process as well. As a result of the Vision Study, the Town has a new draft Master Plan currently under review that will likely be adopted early in 2008. I thank Councilwoman Laurie Insel for leading this very successful undertaking.

Thank you for allowing me to continue to serve as your Mayor for the next two years. It's been one of the most rewarding experiences of my life and I look forward to continuing to work with our Town Council. Congratulations to Councilmen Jack Harrison and Todd Pender who will continue to serve for the next three years. I thank Michelle Harrison for her hard work from which the Town will continue to benefit on our Planning Board and Smart Growth Committee.

However, we should not forget the less fortunate families that have suffered the devastation of a fire. Too many families will find themselves homeless or in this tragic state. What can be done to help these and the countless others that might become a statistic? Simply practicing some simple common sense fire safety techniques could pay off in a big way. Remember that the only way that a fire is known to be prevented is if it never occurs.

Be very careful with the use of candles,

Check your heat producing appliances and have them professionally serviced,

Exercise caution with all holiday lights and decorations,

Make sure that you have a fire extinguisher available and that you know how to use it,

Check your smoke and carbon monoxide detectors every week, especially during this season,

Know how to get out of your home in the event of a fire and practice this with your family members,

Keep your pets and young children out of the kitchen while cooking your feasts,

Have your chimney professionally inspected and cleaned,

Do not think that it can't happen to you or a relative because it just might.

Fire Safety starts with you and the smallest step could make the difference. This type of thinking is what fire prevention is all about. Knowing what a fire hazard is, being able to identify the fire hazard and then correcting the hazard. I am never certain if my fire prevention inspections are working and averting

a disaster. I would like to think so since there has not been a major fire in a business within the Town since the Main Street Fire. (I don't want to talk too loud on that one.)

Once a major incident does occur, the event is on everyone's mind for a time. 6:00AM TO 8:00 PM



Are you registered yet? You must be registered 21 days before an election to be eligible to vote in it. You can obtain a voter registration application at the municipal building, county office, library, or on the county web site at www.co.hunterdon.nj.us/pdf/voterregapp.pdf.

Are you voting by mail? Your mailed application must be received at least 7 days before the election. If you choose to hand deliver it to the county office in Flemington the deadline is 3:00pm the day prior to the election for civilians and 8:00pm election day for military personnel. You can obtain an absentee ballot application at the municipal building, county offices, library, or the county web site.

Are you voting in person? Polling takes place at the Community Center on Halstead Street.

Leaf Collection

Leaf collection will begin in Mid-October and will continue until approximately Mid-December. There will be multiple trips through all neighborhoods for the duration of the leaf collection program, so if leaves are not out when the crew goes by they will be picked up next time. We are also requesting that neighbors be cognizant of others and, if possible, cover leaves with a tarp so that leaves don't blow on other properties.

Brush/Yard Debris

Brush and yard debris will start again after leaf collection. Residents can take their debris to the Treatment Plant located down Ramsey Road, Mon thru Fri from 8:30am to 4:00pm and Sat & Sun 6am to 9am.

Trash Receptacles:

Please take all necessary steps to keep your trash dry. Rain water adds additional weight to your trash. Less weight keeps the disposal costs down.

WINTER OVERNIGHT ON-STREET PARKING

To facilitate snow plowing and snow removal by our Public Works department, Ordinance 135-24 prohibits overnight parking on ALL public streets in Town from November 15 to April 1 every year during certain times. The hours of prohibited parking on Main Street and East Main Street are from 11pm and 6am, and between 2am and 6am for ALL other streets in Town.

If you have overnight guests, other special parking needs or your vehicle is disabled please contact the police department IMMEDIATELY and PRIOR to the hours of restriction so that we may try to accommodate your needs.

SNOW REMOVAL FROM SIDEWALKS

So that our school children and other pedestrians can find safe passage on our sidewalks, Ordinance 115-1 requires that the owner or tenant of property abutting or adjacent to a sidewalk must remove all snow and ice from that sidewalk or public right-of-way within 12 hours of daylight from the time that the snow or frozen precipitation ceased to fall or accumulate.

These are some lessons from years past about snow/ice removal:

1. Its much easier to remove the snow/ice IMMEDIATELY after it ceases to fall than it is after it melts and then re-freezes.
2. Don't count on the snow or ice melting and disappearing by itself within 12 hours of daylight after it ceased to fall (see lesson #1 above).
3. It is illegal to deposit snow or ice from your sidewalk or driveway onto the street AFTER the street has been plowed. You WILL be reported by the Public Works Department and you WILL receive a summons if you are caught doing this.

4. There are many seniors in Town who find it difficult if not impossible to shovel their sidewalks and driveways, so help a neighbor who may need it. This is also a great opportunity for teenage entrepreneurs to make some extra spending money. If you would like to be contacted to help someone in need of shoveling assistance please contact the Clerk's Office at the municipal building.

CHRISTMAS PARADE

On Friday December 7th at 7pm, Clinton will again host our famous Christmas Parade. Here are some things that you should know and PLAN AHEAD to make this night fun, memorable and safe for everyone.

1. The Halstead Street Bridge will still be closed to vehicular traffic, however pedestrian access will remain across the bridge. Your guests will be able to park on Halstead Street, at the Community Center and the County Library which are excellent places to park and walk into Town. Shuttle buses will also run regularly from the Community Church on Route 513 near Wal-Mart into Town.
2. There will be no parking on Main Street, East Main Street, Center Street and Leigh Street north of Route 173 from 5pm parade day until its conclusion and all streets are re-opened. Any vehicle parked on these streets after 5pm is subject to be towed at the owner's expense.
3. To avoid inevitable traffic congestion and delays please let your guests know that it is best to arrive in Town as early as possible. I strongly suggest unless it is absolutely necessary for them to drive into Town, that after 5:30pm they park as far from downtown as possible and take a leisurely stroll in.
4. Access to Center Street will be restricted and controlled by police

from both ends beginning at 5pm. Every effort will be made to accommodate residents and your guests however after 5:30pm all access to Center Street must be from the east (McDonald's end).

5. Individual vehicles will not be permitted to make parade participant drop off's on Center Street after 6pm. Parade participants should be dropped off on perimeter streets such as Halstead, Georges Place, Leigh Street or Route 173 and then walk to their starting position or floats on Center Street.

6. For safety reasons, based upon the volume of pedestrian traffic in the downtown area Main Street, East Main Street, Lower Center Street and Leigh Street are subject to closure at anytime after 5:30pm.

7. Every year some residents and visitors try to reserve "their" seats on public sidewalks along the parade route, sometimes as early as the night before. Please remember that our streets and sidewalks are public property. Tickets are not sold to the parade and there are no "reserved seats" unless it's on YOUR private property. Space on public sidewalks and right-of-ways is on a first come basis only.

8. Please remember that this is a family parade with literally thousands of children and young adults in attendance. NO ALCHOLIC BEVERAGES are permitted to be consumed on public sidewalks or streets at anytime and there will be zero tolerance enforcement of this ordinance on parade night.

9. Above all, have any questions and/or concerns you may have answered or addressed well in advance of parade night because during the event parade organizers, police officers, firemen, EMS Personnel and other municipal officials will be very busy trying to bring you another enjoyable and safe holiday experience in Clinton.

COLD WEATHER EMERGENCIES: HOW PREPARED ARE YOU?

The Clinton First Aid & Rescue Squad, Inc. reminds residents and visitors to take extra precaution during the colder weather. Winter and colder temperatures bring a variety of weather conditions such as snow, sleet and ice, which can easily cause cold weather emergencies. Cold weather emergencies occur when the human body is exposed to prolonged periods of cold temperatures. The elderly, very young and those with pre-existing medical conditions or lack of appropriate shelter are more susceptible to cold weather emergencies such as frostbite and hypothermia.

Frostbite

Frostbite is an injury to body tissue caused by exposure to extreme cold. The nose, ears, cheeks, chin, fingers and toes are the most commonly affected by frostbite. Frostbite is a serious condition that can cause permanent damage and, in the most severe cases, can lead to amputation.

Recognizing the warning signs of frostbite can help avoid permanent

damage. Common signs of frostbite include pain, burning, or "pins and needles" feeling, as well as a hardened feeling of the skin beneath the surface in the affected areas. Skin discoloration, from a grey, blue or waxy white to a waxy yellow appearance, is symptomatic of severe frostbite.

Hypothermia

Hypothermia, or low body temperature, is the result of exposure to cold conditions. It can also occur in moderate temperatures if the person loses heat due to exposure or submersion in water. When you begin to lose heat faster than your body can produce it, your entire body is affected. This can include your brain and your ability to think and react quickly. Signs and symptoms of hypothermia include shivering, exhaustion, confusion, slurred speech and drowsiness.

In addition to recognizing the signs and symptoms of cold weather emergencies, there are a variety of precautions that can be taken to reduce the effects of cold weather on the body. To begin, dress yourself and your children appropriately for the

weather conditions. Wear layers, windproof and waterproof clothing. When layering clothing for insulation, begin with cotton apparel closest to the skin, as cotton absorbs moisture and keeps the body drier. The last inside layer should contain wool material as it retains body heat.

Since 40 percent of body heat is lost through the neck and head, be sure they are properly covered. Face, ears, hand and feet also need to be protected. Shivering is a sign that the body is losing heat and should not be ignored. Finally, limit the body's exposure to extreme cold weather.

The Clinton First Aid & Rescue Squad hopes that you never experience a cold weather emergency, but knowing what to do in case of emergency is vitally important. If you experience, either directly or indirectly, a cold weather emergency, please call 911. That first step is key to activating the resources best needed in an emergency.

Council Highlights by Nancy Burgess

August 14, 2007

~Notification of retirement was received from the Municipal Court Prosecutor. Mayor Schaumburg will work with Mr. Cutter for Request for Proposals to fill position.

~Mayor Schaumburg announced the appointment of Laurel Retajczyk to the Shade Tree Commission.

~A Resolution was read to enter into a interlocal agreement for shared services of a Joint Tax Assessor.

~Application will be sent to DOT for a transportation fund grant for Clinton Knolls Phase II Project.

~A resolution was made to award the contract for a John Deere Backhoe to Jesco, Inc.

~Mr. De Cleene reported the Emergency Services Foundation Fund Drive will hold a car wash on August 18th.

August 28, 2007

~A resident expressed her thanks for the new sidewalk in at the Shell station at Exit 15. Mayor Schaumburg said they are still working on the realignment of the ramp.

~Mayor Schaumburg explained during the public hearing the cost of the School Street/Fox Hill Road Project will be \$90,000. However the Town received a grant from DOT for \$80,000.

~Mr. Cutter explained during the public hearing for the Clinton Knolls Project that the Town received a grant for the 2007 Municipal Aid Program in the amount of \$150,000, a project that will resurface Spruce Run Road, Quarry Ridge Road and Hillside Drive. The Town will apply for a second grant for the Knolls Phase II project.

~Mayor Schaumburg read the Proclamation declaring September as Ovarian Cancer Awareness month.

~Mrs. Insel reported she will pursue a Small Cities Grant to get air conditioning for the Community Center.

~Mr. Ragozine reported revisions to the proposed sign ordinance are with the planner going through the final stages.

~Mr. Pender discussed "Youth Clean Up Day" scheduled for September 16, 2007.

September 11, 2007

~Mayor Schaumburg read a proclamation written by Allie McGaheran at the Women's Club luncheon honoring their 85th Anniversary

~A memo was received by the Planning Board stating their opposition to allowing neon signs in the Historic District.

~The NJ Shade Tree Federation announced their 82nd Annual Meeting to be held October 26 & 27 in Cherry Hill, NJ.

~Mrs. Olsen, CFO reported the finance department plans to move to 47 Leigh St. by the end of the week.

~Mayor Schaumburg reported that Chief Mathies contacted DOT and was informed that they may be adding another phase to the signalization at Exit 15 to address the blind spot when vehicles attempt to turn left at the light when driving into Town.

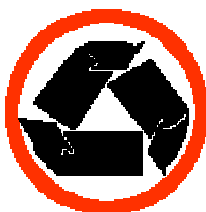
