The Clinton Master Plan Visioning Workshop

What kind of development should take place on the 60 acre industrial property south of I-78? Or on the 30 acres of grass pasture to the north along Route 31?

How can Route 173 be re-designed to be something more than a commercial "strip", and how can West Main Street be re-integrated into the life and fabric of the town?

On Saturday, June 16th from 10am to 4pm, you will be able to answer those questions and others in a way you've never had a chance to before – not just by talking, but by designing. TENTS, TENTS AND MORE TENTS

It's that time of the year again. The time for the outside parties and events that typically will require a TENT to be put up. If your tent is over 900 square feet, over 30 feet in any one dimension, or has a stage or bleacher under it, it requires a fire safety permit to be applied for and an inspection by the Fire Marshal. Last year, approximately 10 tents went up without the necessary permit. Most tents were put up by commercial business entities. Sometimes the applications were not received until the day before the event however the tent was already put up. The bottom line is that this permit must be applied for in advance to allow time to process the application and obtain any missing information. The typical information needed would be the tent flame resistance certificates, a layout of the location of the tent/s, the size of the tent/s, the intended use and if there will be sides on the tent/s. Additionally, a seating arrangement is required to assist in determining the occupant load for the tent/s. No cooking is permitted under the event tent. A SEPARATE "cooking" tent

would be needed in this case, which will require a fire safety open flame permit to be applied for and issued.

It is very important to apply for these permits well in advance of your event. If you are planning to have an event where a tent will be used, ask the property owner or representative if the fire safety permit has been applied for. There are enough reasons besides the fact that the fire code requires the permit. Things such as how the tent is anchored are inspected. If a strong wind were to occur, the tent has to be able to resist the upward force of the wind. The location is important so as not to have an adverse affect on another structure. Exit paths and signs are necessary especially if the tent has sides used to enclose the area under the tent.

On another note, did you know that an electrical appliance has power to it even if it is not switched on? If you think about it, you would say of course I know that. But most people don't think about this and forget that an appliance that is plugged in has electricity up to the "on/off switch". Think of your faucet at your sink. The faucet is like the switch. Water is waiting at the faucet for use. Turn the

faucet and you have water. Well, electricity is waiting at the switch to be used. Turn on the switch and electricity runs to the appliance making it work. So your appliances that are plugged in but not turned on STILL have electricity in them up to some point (where the switch is). This is important to remember. Don't cover the electrical cords. This could cause a build up of heat, which could cause the cord to break down and become brittle over time. Unplug your high-end appliances such as computers, air conditioners, TVs, stereos, game systems, etc. These appliances require a lot of power. Try to protect these appliances with a UL listed surge suppressor. This will help overloading during lightening storms or when the power comes back on in the event of a power outage.

LYME DISEASE Action Alert

In Hunterdon County, deer ticks – also referred to as "black-legged" ticks are the only ticks that transmit Lyme disease. Deer ticks do not jump, fly or drop from trees, you must brush against or otherwise come in direct contact with them. Before going into tick habitats:

1. Wear light-colored clothing.
2. Tuck shirts into pants & pants into socks.
3. Apply tick repellent to your skin or clothing.

MOSQUITO CONTROL AND WEST NILE VIRUS

West Nile virus is a mosquito-borne virus that can cause West Nile encephalitis (swelling of the brain). West Nile Virus is transmitted through the bite of an infected mosquito. The virus is found in wild bird populations such as crows. If you discover a dead crow on your property, call the Hunterdon County Health Department at 908-788-1351. The crow must be dead less than 24 hours to be tested, so call immediately upon finding the bird. A representative from the Health Department will come and pick the bird up from your location and have it tested.

A report will be made at the Health Department. Domestic animals such as cats and dogs do not appear to be at risk for WNV infection.

DOG AND CAT LICENSING

Dogs and cats are required to be licensed in the Town of Clinton. Licensing ensures proper rabies vaccinations in pets and protects them and their owners from infection. Dogs are required to be leashed. It has come to our attention that small traps have been set in our Town and have caused injury to pets. **CERTAIN TRAPS ARE PROHIBITED, IF NECESSARY, PLEASE USE HAV-A-HEART TRAPS TO ENSURE THE SAFETY OF YOUR PETS AND OTHERS.**

Summer Fun and Safety Reminders.

As we move into the summer months I thought it would be a good idea to remind "everyone" about two timely topics before they become an issue for "anyone":

The Town Noise Ordinance – Chapter 101 of the Code of the Town of Clinton addresses "unreasonable and/or unnecessary noise" which travels across real property lines and it also specifically addresses that noise which is created by "sound reproduction devices". Sound reproduction devices include but are not limited to musical instruments, radios, T.V.'s, tape recorders, phonographs, loudspeakers, P.A. systems or any other sound-amplifying devices.



Let me start by saying that there are many activities that by their very nature will immediately violate this ordinance. Therefore, the ordinance contains provisions for exceptions (public safety, emergency work, construction activities, activities on public grounds under authority of Town Officials) or provided that the Mayor and Council may grant a permit for a specific activity to be an exception to the ordinance for a specific period of time (concerts, merchant events, etc.). The nuts and bolts of this ordinance is "unreasonable noise" which is not an exception contained in the ordinance or authorized by Town Council. Unreasonable noise is defined as "any excessive or unusually

loud sound or sounds which annoy, disturbs, injures or endangers the comfort, repose, health, peace or safety of a reasonable person of normal sensitivities or which causes or has the potential to cause injury to animal life or damage to property or business". Unreasonable noise can be many things to many people however the Police Department considers the following standards when determining whether there is a violation of the ordinance: volume, intensity, is the nature of the noise usual or unusual, is the origin of the noise usual or unusual, the volume and nature of any background noise, proximity to residential sleeping areas, nature and zoning of the area, time of the day or night, duration of the noise, is the sound source temporary, is the noise continuous or impulsive and whether the noise would disturb the peace and/or be considered a common-law nuisance.

Now I know your wondering what does all that mean right? What it means is that what is "reasonable" at noon may not be reasonable at 4pm, and what is reasonable at 4pm may not be reasonable at 8pm, and what may have been reasonable at 8pm may not be reasonable at 10pm or later.

The bottom line is that unreasonable noise traveling across property lines is a violation of the ordinance and the common sense rule of thumb that should be used is that as it gets later in the day the volume of any noise should continually be lowered until

at some point the noise cannot be heard by your neighbors.

Fireworks – The Fireworks laws in New Jersey are VERY restrictive. In some States fireworks are permitted to be sold to the public, however, in New Jersey only paper or plastic caps for use in toy cap guns are legal. EVERY OTHER type of fireworks is ILLEGAL and will subject a person who possess or sells such a device to severe penalties upon conviction. Sparklers, novelty items such as cigarette loads, trick matches, trick noise makers, smoke grenades, toy propellants, snap & pops, poppets and champagne poppers as well as firecrackers, Roman Candles, rockets, etc. are ALL ILLEGAL in this State. Please do not be fooled by a salesman who tries to tell you that they are authorized or permitted to be sold by mail order houses or over the internet and please do not purchase fireworks and transport them into New Jersey from Pennsylvania or others States.

Aside from being illegal fireworks are EXTREMELY unpredictable and dangerous. Each year many people young and old find themselves in emergency rooms around the State with severe injuries caused by the illegal use of fireworks. Fireworks are also a serious fire hazard. Please leave fireworks to the experts at officially sanctioned public and licensed displays and be reminded that the Police Department and our Fire Code Official have a ZERO TOLERANCE policy for violations of the State's Fireworks Laws.

Clinton First Aid & Rescue Squad by Chad Newsome



My kids and I recently spent a Sunday afternoon hiking around Echo Hill Park. We found ourselves circling the pond and looking for turtles. My youngest daughter, Kate, age 4, was very interested in the turtles there. I felt like a broken record with my constant urgings for her to be careful. While the "adventure" was incident free, it did provide me with a topic for the June edition of the Town of Clinton Newsletter.

According to the U.S. Consumer Product Safety Commission (CPSC), an estimated 260 children under five years of age drown each year in residential swimming pools and spas. The Commission estimates that another 3,000 children under age five are treated in hospital emergency rooms following submersion accidents each year. Some of these submersion accidents result in permanent brain damage.

Nationally, drowning is the fourth leading cause of death to children under five. In some states such as California, Florida and Arizona, drowning is the leading cause of accidental death to children under five.

The Clinton First Aid & Rescue Squad has two rescue boats, certified divers and swift water rescue personnel as part of the services that we provide to

residents and visitors to the Town of Clinton. However, in regards to backyard pool safety, the following tips can help you enjoy fun in the sun this summer, while limiting the chances for avoidable emergencies:

- Never leave a child unsupervised near a pool.
- Instruct babysitters about potential hazards to young children in and around swimming pools and the need for constant supervision.
- Completely fence the pool. Install self-closing and self-latching gates. Position latches out of reach of young children. Keep all doors and windows leading to the pool area secure to prevent small children from getting to the pool. Effective barriers and locks are necessary preventive measures, but there is no substitute for supervision.
- Do not consider young children "drown proof" because they have had swimming lessons; young children should always be watched carefully while swimming.
- Do not use flotation devices as a substitute for supervision.
- Never use a pool with its pool cover partially in place, since children may become entrapped under it. Remove the cover com-

pletely.

- Place tables and chairs well away from the pool fence to prevent children from climbing into the pool area.
- Keep toys away from the pool area because a young child playing with the toys could accidentally fall in the water.
- Remove steps to above ground pools when not in use.
- Have a telephone at poolside to avoid having to leave children unattended in or near the pool to answer a telephone elsewhere. Keep emergency numbers at the poolside telephone.
- Learn CPR (cardiopulmonary resuscitation).

Keep rescue equipment by the pool. These tips will serve to lessen the chances for a water emergency at your home this summer. While accidents can happen despite our best efforts, parents and guardians are the best way to prevent a drowning. Watch your child closely at all times. Make sure doors leading to the pool area are closed and locked. As always, the squad offers CPR training and we are always looking for new members. Council Highlights by Colleen O'Reilly

February 13, 2007

- ~ The Landlord Registration form and the proposed Historic Preservation Ordinance were discussed.
- ~ Councilwoman Insel has been working with the Smart Growth Committee on the Regional Plan.
- ~ The Planning Board made recommendations to the Mayor and Council to install a 20 X 6 baseball scoreboard sign at Gebhardt Field. Council approved the request.
- ~ A summer rec. registration fee was proposed \$5 per child or \$10 per family. Council approved the proposal.
- ~ The Clinton Historic House Tour will be held on October 7, 2007.
- ~ An ordinance was passed authorizing the making of improvements in the Clinton Sewer Utility and appropriating the sum of \$150,000 from the sewer capital improvement fund.
- ~ The Bond Ordinance for the appropriation of \$450,000 for the Clinton Mills Dam/Dike was discussed.
- ~ The resolution to submit an application for a Highlands Planning Assistance Grant to the Highlands Commission to seek funds to conduct scientific work to take Well 16 out of the planning area.
- ~ Mayor Schaumburg announced that the Hunterdon County Open Space Trust Fund has granted the Town of Clinton's request for \$60,462.

February 27, 2007

- ~ A discussion was held about the water main breaks in the Clinton Knolls area; Mayor Schaumburg explained that the Town plans on repaving the entire development.
- ~ Christine Wood was appointed to the Historic Commission.
- ~ Mayor Schaumburg announced the 18.83% or \$1,384 savings in garbage costs due to the new recycling program.
- ~ Mr. Harrison discussed special grants for 2008 for the First aid & rescue squad, Fire and Police departments.
- ~ The Highlands Council has granted the Town of Clinton \$35,000 to study Well 16.

~ Janice Kovach, Director of the Division on Women, present at the meeting, requested all municipalities to proclaim the month of March as Women's History Month. Mayor Schaumburg expressed the support of the Council.

- ~ Kids Day America was discussed and will be held in April or May.
- ~ The Bond Ordinance for the Clinton Mills dike and dam project was presented and approved for \$450,000.
- ~ A resolution for the Town of Clinton to participate in the Public Archives and Records Infrastructure Support program (PARIS) was explained and adopted.
- ~ Arbor Day celebration will be held on April 27, 2007 and a new cherry tree will replace the one destroyed in the 2003 fire on Main street.

March 13, 2007

- ~ Mayor Schaumburg reviewed the recycling savings from last February; they are down \$3,291 from the same time last year.
- ~ The Town of Clinton adopted an ordinance permitting the bidding process to take place on a new hotel liquor license.
- ~ The Clinton Sunrise Rotary will hold the Annual Rubber Ducky Race on Sunday July 15 from 11 am to 2 pm and the Sprintin' Clinton on the same day from 6 to 8 pm.
- ~ Mayor Schaumburg presented the 2007 Budget and discussed a few items.
- ~ State Aid was increased by \$4,573.
- ~ Town of Clinton was advised that the 2007 Department of Environmental Protection allocation will be approximately \$4,000 under the Clean Communities Program.
- ~ Mr. Cutter reported on the progress of 47 Leigh Street project.

March 27, 2007

- ~ Mayor Schaumburg appointed Jessie May to the Sign Committee.
- ~ Mayor Schaumburg discussed a meeting with Acting Superintendent John Sansky and Board of Education Business Administrator, Lisa Ayers. They gave an overview of the School budget for 2007-2008 and explained a

3.2% increase due to contractual salaries.

- ~ Marcia Sudano-Kerwin, Tax assessor, made a presentation to the Council and reported that she has received three tax appeals.
- ~ A resolution was passed supporting the submission of the Association of NJ Environmental Commission Grant Program Application, which will fund a build-out analysis for the Town.
- ~ The Hunterdon County Chamber of Commerce will hold the Hunterdon HorseXpo on May 19 and 20 at the South County Park in Ringoes.
- ~ Councilman Ragozine discussed potential renovations to Gebhardt Field, including the dugouts.
- ~ Councilwoman Insel reported on the Smart Growth Committee and upcoming topics of discussion to be addressed are streetscapes, traffic, parking, downtown revitalization.

April 10, 2007

- ~ Kids Day is scheduled for April 21 at the Community Center.
- ~ Mayor Schaumburg reviewed the solid waste savings for the Town due to the new recycling program; over the past three months the savings has been \$6,084 compared to the same time in 2006.
- ~ Assemblywoman Marcia Karrow made a presentation to the Council.
- ~ Mayor Schaumburg read the proclamation proclaiming April Autism Awareness Month.
- ~ Mayor Schaumburg read proclamation for the Community Transportation Services Day.
- ~ The Mayor read the Safe Kids Week 2007 proclamation promoting childhood injury prevention. The Town received a donation of 10 bicycle helmets from Johnson & Johnson to be given away at Kids Day.
- ~ Auditor Warren Korecky attended the meeting to answer questions pertaining to the 2007 budget.
- ~ Mayor Schaumburg announced that the Town is in receipt of \$230,000 that will be used to fund road work in the Knolls and School Street projects.

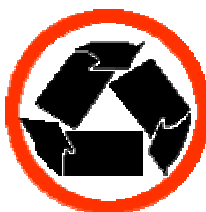
