From the Mayor's Desk...

I hope this letter finds all of you well. We've certainly experienced a strange winter with temperatures in the 70's in December and single digits recently. I know I am looking forward to Spring more than most years.

I've been planning a LifePrint Identification event to be held this Spring for Town of Clinton children with Patrol Officer Leon Cohen. LifePrint technology records your child's DNA. While we are in the early stages of planning, we will make this a festive community event with fun activities for Clinton kids. This very important event will be funded by corporate sponsorships and DARE bin proceeds.

Also this Spring, our Smart Growth Committee will be holding a Charette. A Charette is a community event during which residents, merchants and commercial property owners work with professional planners, traffic engineers and architects to create a Vision Study for the Town. The Study will focus on traffic calming, beautification, architectural standards and revitalization opportunities, especially on the Old Highway 22 corridor. We hope for strong participation as we will be planning for the future of Clinton and the plan will be best if it comes from you. The Vision Study which will be incorporated into the Town's Master Plan is funded by a \$60,000 County Open Space Trust grant and a \$45,000 Smart Future grant from the New Jersey Office of Smart Growth.

The Town Council held our final budget workshop in February. For the third consecutive year, we worked hard to prepare a budget with a flat tax levy and a decrease in the municipal tax rate. This year was challenging as we realized many increases in costs such as an \$84,000 increase in pension and insurance with no increase in state aid. However, \$335,000 in grant awards to the Town of Clinton and excellent fiscal management helped us achieve a flat budget without cutting any services.

Finally, thank you to everyone who has contacted me with feedback on our new recycling program. Look for more "Green" programs coming soon to the Town of Clinton.

Interesting Information about our Sewer System by Paul Klitsch, WWTP Superintendent

Did you know:

The Town of Clinton Wastewater Treatment Plant went on line in 1969, serving a population of about 4,000 from Clinton, High Bridge, and State of NJ Facilities (Hunterdon State School and Edna Mahan Correctional Facility). In August 1969, 12.3 million gallons of wastewater was treated.

Today, the Wastewater Plant serves a population of about 13,000, not only from Clinton, High Bridge and the State but also from the following: Annandale, Beaver Brook, Deer Meadow, Oak Knoll and Water's Edge Sections of Clinton Township; The Cracker Barrel Restaurant, Hampton Inn, South Ridge Community Church, and the Wal-Mart / Shop Rite Plaza in Franklin Township; Union Gap Village, Union Hill Condos, and The Foster Wheeler Corporate Park in Union Township; the State of NJ Water Supply Authority offices and Spruce Run Reservoir Recreation area; and North Hunterdon and Voorhees High Schools.

In October of this year, 40.3 million gallons of wastewater was treated. Since its inception, the Clinton Plant has treated well over 10 billion gallons of wastewater, or enough to fill Spruce Run Reservoir to capacity.

Last upgraded in 1993-1994, the Plant typically removes 98-99% of conventional pollutants, far exceeding the NJ DEP's minimum removal rate of 85%.

A Message from the Water Department by Tom Tharp, Water Superintendent

DEFINITIONS:

1. Water Restriction – restrictions on all unnecessary use of water for example car washing, lawn watering with automatic sprinklers, washing sidewalks, porches, ornamental uses. These restrictions are implemented when water levels become low in wells or demand is more than we can produce in a day.
2. Water Conservation – limiting the use of water to prevent the depletion of potable water for drinking and fire protection. These conservation measures are in effect 12 months a year.

The State of New Jersey Department of Environmental Protection has set Specific and General Conditions under our water allocation diversion permit. Specifically, the Town of Clinton Water Department shall adopt and implement a continuous program to encourage water conservation of all types of use within the area served.

There is a misconception that water conservation measures are the same as water restrictions. I hope I have clarified the difference. I ask a question that might seem harsh, but it's true: "Would you rather have brown grass or brown water?" Grass will always come back; water may not.

Spring Clean-Up The spring leaf collection will begin on Monday, March 26 and continue for 2 weeks ending on Friday April 6 (weather permitted). Rake leaves to curb. No bags. The leaves must be placed more than 10 feet from storm drains.

Stormwater ABC’s Stormwater pollution happens because dirty water contaminated with debris like trash, cigarette butts and dog poop, goes from the street into our creeks, bays and the ocean. This dirty water flows through storm drains, so it’s called stormwater pollution. Here are some other important stormwater words:

C is for Catch Basins: these are the openings in the gutter of the street.
R is for Run Off: when it rains, or when people use their sprinklers or a

hose the water runs down into the catch basins. This runoff mixes with garbage, motor oil and other debris in the street and flows out into the streams.

S is for Storm Drains: concrete pipes which carry the water runoff.

C is for Contamination: Pollutants that makes water unsafe.

W is for Watershed: We all live in a watershed, a large area where water drains through the streets, river beds and mountains down to the ocean. Understanding how watersheds work helps us understand how to keep our rivers, lakes and ocean clean.

PEDESTRIAN SAFETY

With warmer weather comes increased pedestrian traffic throughout Clinton.

It is extremely important that our pedestrians and motorists are aware of their separate but equal responsibilities at a crosswalk. Pedestrians must stop at the curb, look both ways and proceed only when safe to do so. Motorists must yield the right of way to a pedestrian who has entered the crosswalk. After dark, pedestrians should wear light or reflective clothing and motorists should pay extra attention at intersections and crosswalks for the unexpected. If either a pedestrian or motorist neglects their responsibilities at a crosswalk, the results can be tragic and expensive for both. The police department takes pedestrian safety very seriously and will be actively enforcing the law at our crosswalks.

HOUSE NUMBERS

Our officers have had some difficulty responding to emergency calls at several of our residences in Town recently because they were not properly marked with a street address that could be easily identified from the street or sidewalk. When an emergency happens seconds are critical to responding police, fire or rescue personnel. Please take the time to check your property to make sure that your house, apartment or building number is clearly marked and visible from the street so that critical seconds can be spent on your emergency and not on trying to find it!

OVERNIGHT PARKING RESTRICTIONS

Winter overnight parking restrictions end March 31st until next winter, yea!

CHILD SAFETY SEAT INSPECTIONS

Residents are encouraged to take advantage of our Child Safety Seat Inspection Program.

To have our child safety seat inspected contact our technician Tim McGuire at 735-8611 and make an appointment for an inspection. These inspections take approximately one hour and there is no cost. Inspections are also available at the Hunterdon Medical Center by appointment.

TRAFFIC MANAGEMENT

Similar to New York City's "Traffic Stat" Program, the Town's Traffic Management Program continually identifies, targets and then re-evaluates specific locations, violations and other traffic concerns in Town for our officers to target during their patrol shifts for ENFORCEMENT. If you have a specific traffic concern in your neighborhood please contact the department so that it can be evaluated and addressed through this program.

SKATEBOARDS, SKATES, ROLLERBLADES and SCOOTERS

We receive hundreds of inquiries annually regarding State law and our local ordinances governing skateboards, skates, scooters and other locomotion devices that are gas or electrically powered. Skateboards, skates and non-motorized scooters are considered "human powered" locomotion devices. They are prohibited from being operated on any street, highway or other area of Town designed for motor vehicles by ordinance. *Additionally they are prohibited from being operated on the sidewalks of Main Street, Lower Center Street, East Main Street and the*

section of Leigh Street from Route 173 to Center Street. Although they are sold in stores and on the internet, gas or electrically powered skateboards, scooters or any other "motorized" locomotion device are considered motor vehicles under current law and the operation of such powered devices is prohibited on any public street or sidewalk in New Jersey. Operation of these motorized devices on public streets can subject the operator to being charged under State motor vehicle law with operating an unregistered and uninsured vehicle in addition to any other traffic violation they may be committing, **REGARDLESS OF AGE.** If you have ANY questions regarding ANY motor vehicle law or Town ordinance regulating any of these devices **PLEASE ASK** an officer **FIRST.** Also, please remember that if you are under 18 years of age you **MUST** wear an approved helmet, even on a bicycle.

FINGERPRINTING

Since 9/11 fingerprinting has become required for a variety of purposes. If you live in Clinton or the employer requiring you to be fingerprinted is in Clinton, you can call the department at 735-8611 and make an appointment to be fingerprinted.

Clinton First Aid & Rescue Squad by Chad Newsome



If you live here, you have experienced it. How many times do you find yourself stuck out on Route 78, not moving, wondering when you will get home? As you sit there in stopped traffic, you hear the sirens. Another accident...

We here in Hunterdon County do not hold the record for the best or the worst roads. However, the majority of accidents could be prevented by following some basic safe driving principles. While many of these may seem fundamental, there are some drivers who feel it is completely acceptable to simultaneously use their laptops, chat on their "hands free" cell phones and eat their meals – all while driving at 75 miles an hour!

If someone else is in the car, you should refrain from talking with your hands and realize that you are doing something that could, in one instant, become life threatening. When speaking with someone else in your car, don't feel as if you need to look at them when carrying on a conversation. Keep your eyes on the road and save those social graces for the dinner table. Remember that cell phones and all other distractions increase your chances of having an accident.

Always remember to buckle your seat-belt even if the ride is just around the

corner. Keep your children in proper restraint seats or properly adjusted safety belts if they are older. Keep your rear view and side mirrors adjusted for maximum visibility. The Hunterdon Medical Center (908-788-6667), the Hunterdon County Prosecutor's Office (908-788-1129) and other area agencies have Child Seat Safety Programs.

If you wish to be seen more easily in daily traffic, consider using your headlights during the daytime and always remember to use your headlights when traveling on 2-Lane highways regardless of the time of day.

There is an old saying... "If the roads are wet, then drive like it is snowing. If the roads have snow, then drive like they're icy. If the roads are icy, then don't drive." Bridges and overpasses freeze first. Slow down and avoid sudden changes in speed or direction. Keep windows clear of snow and ice. Keep your speed steady and slow -- but not too slow. In deeper snow, it's often necessary to use the car's momentum to keep moving. Use brakes very cautiously. Abrupt braking can cause brake lock-up, which causes you to lose steering control.

Antilock brakes are designed to overcome a loss of steering control on wet

or slippery roads. Yet they have little or no effect on ice. To make antilock brakes work correctly, or work at all, you should apply constant, firm pressure to the pedal. During an emergency stop, push the brake pedal all the way to the floor. If you get stuck in snow, straighten the wheels and accelerate slowly. Avoid spinning the tires, because the heat friction caused by spinning tires melts the snow and creates a thin layer of ice. Use sand or cinders under the drive wheels to increase traction if you get a little stuck. Never stand in traffic to push a car that's stuck. Someone else could lose control and seriously injure or even kill you.

The road becomes slippery as water mixes with road oils, grease and dirt. Also, your car's tires tend to ride on the surface water, reducing traction. Slow down. Visibility is often impaired. Turn on your head lights at the first sign of rain. Use the defroster or air conditioner to keep windows and mirrors clear.

We all share a responsibility for each other each and every time we get behind the wheel. Just like many of you, the time that I spend commuting – 75 miles, each way, each day – can quickly double with any automotive mishap. We all would benefit greatly by just taking the time to be just a little bit safer.

Historical Preservation Commission by Laurie Insel

The Clinton Historic Preservation commission has been working on Historic Preservation issues in the Town of Clinton for many years. Within the past year, the NJ Office of Smart Growth and the Hunterdon County have concluded that the Historic Element of our Master Plan as well as the lack of Design Guidelines as they

relate to our historic town need to be studied and adopted into the Municipal Master Plan. The preparation of a Historic District Ordinance, that meets the present needs of the community is part of this process.

The Historic Preservation Commission has spent the last year studying

different ordinances in many successful towns such as Summit, Madison and Westfield to come up with a plan that would fit with our community's needs. The proposed draft ordinance is available at the municipal office to anyone for comment or question.

Council Highlights by Colleen O'Reilly

October 24, 2006

~ Matthew Sergison, a 6th grader at Clinton Public School, attended the meeting with his teacher, Doreen Bleck. Matthew presented the council with a poem and pictures depicting the wonders of Clinton.

~ Mayor Schaumburg addressed the status of the Exit 15 construction project.

~ Councilwoman Insel reported on the Historic Commission. They are working with the Master Plan committee with regards to the historic portion of the plan, to make it easier for residents to comply with when doing work on their homes.

November 9, 2006

~ Prior to the meeting, Todd Pender and John Harrison were sworn into their new positions on the council.

~ Two membership applications for the Clinton Fire department were approved for Daniel Beadle and Ryan Beattie.

November 28, 2006

~ Mayor Schaumburg reported on the League of Municipalities in Atlantic City.

~ The Town received a \$45,000 Smart Future Grant, which will be used toward the Vision Study.

~ The Town also received a \$10,000 HART grant for Part II of the Bike

and Pedestrian Path Study.

~ The DOT awarded a \$150,000 grant for the Clinton Knolls Road Work.

~ A discussion was held around the proposal to change the Parks and Playgrounds Commission to a Recreation Committee.

December 12, 2006

~ Laurie Insel announced the news that the County Open Space Advisory Committee recommended funding the Town of Clinton's \$60,000 application request.

~ DOT has notified the Town of a grant of \$80,000 for local transportation improvements. This will be used for the School Street project.

~ Councilman Harrison reported that the Sewer Committee is looking into solar energy panels to be placed on the roof.

December 26, 2006

~ A discussion was held around the placement of guard rails at the exit 15 intersection in front of the Shell station. Mayor Schaumburg reported that she and Police Chief Matheis will contact NJDOT.

~ Mayor Schaumburg reported on all of the many accomplishments that occurred in 2006 for the Town of Clinton, which included the Halstead Bridge project, the approval of many grants for the Town and the Exit 15 project.

~ Mayor Schaumburg thanked Councilwoman Joelle Garber for her three years of service to the Town and her many accomplishments. Joelle was instrumental in the development of the Town website, improvements to the Newsletter and helped build the Emergency Services Foundation.

~ Councilwoman Garber thanked everyone for having the opportunity to serve on the Council.

January 9, 2007

~ Mayor Schaumburg explained that the Sign committee is attempting to enforce the temporary sign ordinance.

~ Joelle Garber announced a hair cut-a-thon will be held at Arlene's Beauty shop on Jan 27 from 1 to 6 pm with proceeds to go to the Higgins family.

~ Mayor Schaumburg reported on her visit to Trenton to attend the State of the State address.

~ Mr. Cutter discussed the newly enhanced recycling program and said that FAQ's (frequently asked questions) will be on the website.

~ Mr. Cutter also discussed that a letter is being sent to the DOT requesting fencing to be placed on the Route 78 overpass on Leigh Street, to protect pedestrians along the school path and on the sidewalk underneath the bridge.

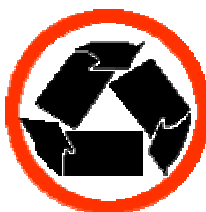
