THINK SPRING

"BE COUNTED IN 2010"

The importance of Census Data:

- * Every year the federal government can allocate more than \$300 billion to states and communities based, in part, on census data.
- * Census information helps determine locations for schools, roads, hospitals, job training, child-care and senior citizen centers, and more.
- * Census data determine how many seats each state will have in the U.S. House of Representatives as well as the boundaries of legislative districts.

2010 Census Time Line: Key Dates

February - March 2010	Census questionnaires are mailed or delivered to households.
April 1, 2010	Census Day. (Questionnaire responses should represent the household as it exists on this day.)
May - July 2010	Census takers visit households that did not return a questionnaire by mail.
December 2010	By law, Census Bureau delivers population counts to the president for apportionment.
March 2011	By law, Census Bureau completes delivery of redistricting data to states.

2010 Census Questionnaire: Quick, Easy, and Confidential

- * With only 10 questions, the 2010 Census questionnaire is one of the shortest questionnaires in history and takes just 10 minutes to complete.
- * By law, the Census Bureau cannot share an individual's census responses with anyone, including other federal agencies and law enforcement entities.

How To Save Water Outside the Home

The rate of consumption for water-saving devices or products varies significantly. Check the packaging on the plumbing fixture or product you purchase to determine its water efficiency. Warm weather means more outdoor activities and more outdoor water use. Be as careful and efficient outdoors as you are inside your home.

Hoses:

1. Check hoses and hose connectors. Repair or replace leaky parts or sections.
2. Use a nozzle that can be shut off or adjusted to fine spray. When finished, shut off at the house instead of at nozzle to avoid leaks.

Lawn and Garden:

1. Water slowly and thoroughly during cool, windless hours, as infrequently as possible. Let grass grow taller in hot weather. Use mulch in the garden and around shrubs to save moisture. Plant native and other shrubs that don't need a lot of water.

2. Re-using water is a good idea. Some cleaning water and pool water is fine for watering lawns and gardens.

Car:

1. Rinse car once, wash from bucket of soapy water, rinse quickly again.
2. Used water is fine for chrome, hub caps, and wheels.

Green Tips

Think before you buy:

1. Go online to find new or gently used secondhand products. Whether you have just moved or are looking to redecorate.
2. Check out garage sales, thrift stores, and consignment shops for clothing and other everyday items.
3. When making purchases, make sure you know what's "Good Stuff" and what isn't.

4. Watch a video about what happens when you buy things. Your purchases have a real impact, for better or worse.

Make your own cleaning supplies:

1. The big secret: you can make very effective, non-toxic cleaning products whenever you need them. All you need are a few simple ingredients like baking soda, vinegar, lemon, and soap.

2. Making your own cleaning products saves money, time, and packaging not to mention your indoor air quality.

NJ Board of Public Utilities - "Local Government Energy Audit Program"

The Town of Clinton has recently obtained a \$69,000 grant to fund energy audits for municipal and utility owned buildings. These buildings include the Municipal Building, Community Center, Waste Water Treatment Plant, and various water utility pump houses. The audit is anticipated to take approximately 17 weeks. Once the audit is complete, implementation of the energy cost saving measures will be implemented. Additionally, the Town will request funding through various BPU Incentive Programs, in order to implement the cost saving improvements.

PEDESTRIAN SAFETY

Clinton is a pedestrian-friendly Town and not only do we want to keep it that way, we want to make it even friendlier. It is extremely important that pedestrians and motorists are aware of their separate but equal responsibilities at a crosswalk. Pedestrians must stop at the curb, look both ways and proceed only when safe to do so. Motorists must yield the right of way to a pedestrian who has entered the crosswalk. After dark, pedestrians should wear light or reflective clothing and motorists should pay extra attention at intersections and crosswalks for the unexpected. If either a pedestrian or motorist neglects his or her responsibilities the results can be tragic and expensive for both. Unfortunately, every year hundreds of pedestrians are injured and many are killed; that's why the Police Department takes pedestrian safety very seriously and we actively enforce pedestrian laws at our crosswalks.

HOUSE NUMBERS

Emergency responders frequently STILL have difficulty responding to emergency calls at some locations throughout Town because they are not properly marked with a street address that can readily be identified from the street or sidewalk. When an emergency happens seconds are critical to responding police, fire or rescue personnel. Please take the time to check your property to make sure that your house, apartment or building number is clearly marked and visible from the street so that those critical seconds can be spent on your emergency and not trying to find it!

OVERNIGHT PARKING RESTRICTIONS

Winter overnight parking restrictions for this season will end March 31st, but until then please do not park on any street in Town between 2:00am and 6:00am when snow is forecast

during those hours, or when streets are snow-covered during those hours. Your car will receive a summons and may be towed at your expense.

CHILD SAFETY SEAT INSPECTIONS

Residents are encouraged to take advantage of our Child Safety Seat Inspection Program.

To have your child safety seat inspected, contact our technicians (Patrolmen Leon Cohen or Tim McGuire) at 735-8611 and make an appointment for an inspection. These inspections take approximately one hour and there is no cost. Inspections are also available at the Hunterdon Medical Center by appointment.

CELL PHONES AND TEXT MESSAGING

We urge you to concentrate on the road and the operation of your vehicle, and not on a text that someone just sent you or that you feel like sending. Cell phone use or texting while operating your vehicle is dangerous and will result in your receiving a summons if you are seen using one while driving in Clinton. Our Town is too busy and too small for motorists to pay attention to anything other than driving. WWW.NJSAFEROADS.COM.

SKATEBOARDS, SKATES, ROLLERBLADES & SCOOTERS

In addition to hundreds of complaints about their improper operation, we receive many inquiries each year about State law and our local ordinances governing skateboards, skates, scooters and other locomotion devices that are powered by gas or electricity. Skateboards, skates and non-motorized scooters are considered "human-powered" locomotion devices. They are prohibited from being operated on any street, highway or other area of Town designated for motor vehicles by ordinance. Additionally, they are prohibited from

being operated on the sidewalks of Main Street, Lower Center Street, East Main Street and the section of Leigh Street from Route 173 to Center Street. Although they are sold in stores and on the Internet, gas or electrically powered skateboards, scooters or any other "motorized" locomotion device are considered motor vehicles under current law: the operation of such powered devices is prohibited on any public street or sidewalk in New Jersey. Operation of these motorized devices on public streets can subject the operator to being charged under State motor vehicle law with operating an unregistered and uninsured vehicle in addition to any other traffic violation they may be committing, **REGARDLESS OF AGE**. If you have ANY questions regarding ANY motor vehicle law or Town ordinance regulating any of these devices **PLEASE ASK an officer FIRST**. Also, please remember that if you are under 18 years of age you **MUST** wear an approved helmet, even on a bicycle.

FINGERPRINTING

Fingerprinting is required for a variety of public and private purposes. If you live in Clinton or your employer is in Town you may schedule an appointment to be fingerprinted by calling 908-735-2665 and leaving a message for Detective Sergeant Jay Hunter.

BUSINESS LISTINGS

The police department maintains emergency contact information for all commercial businesses and properties in Town. To keep this information current we must rely on you--the business owner or manager--to keep your contact information updated with new or retiring staff or tenant information. Cadet Program Gaining Steam!

For many years now, the Clinton First Aid & Rescue Squad (CFARS) has looked to its fellow residents to help fill its ranks with various volunteer positions. With both riding and non-riding classifications, CFARS has a very robust membership and 2010 is shaping up as a year of growth! However, CFARS is not content to just recruit those residents who are 18 years old and older.

Aimed at students who are 16 and 17 years of age, the CFARS Cadet Program looks to show younger members of the community how volunteer activism can have lifelong benefits. The CFARS Cadet Program has expanded for 2010 so that we have even more openings on the squad! All interested candidates must have parental permission to join the Cadet Program.

This expanded Cadet Program offers the under 18 year old multiple chances to volunteer. Interested individuals can now ride on shifts that

occur after the school day commitments are through. These are in addition to evening and weekend shifts as well! This flexibility really helps students work around commitments, such as sports and other activities.

For those looking for ways to have their child's college applications stand out, educational advisors have always promoted selfless activity and proactive community participation. CFARS provides all necessary training free of charge. The experience of helping others can really provide a great basis for future community involvement and learning about the Emergency Services will definitely make your child stand out.

The Clinton First Aid & Rescue Squad is volunteer-run, utilizing a hybrid membership of volunteer and paid personnel. This hybrid system ensures in-house staffing and some of the fastest response times in the county. Unique in Hunterdon County, Clinton First Aid & Rescue Squad has an ambulance crew in quarters, seven days a week. The squad operates five ambulances, a heavy rescue truck, a special services vehicle, three boats, a command vehicle and a technical rescue support unit trailer. As one of the busiest EMS/Rescue agencies in Hunterdon County, residents and visitors alike can rest assured that when the need arises, our patients benefit from the strengths of our organization.

Clinton Seniors by Sue Huntley

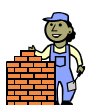

Council Highlights by Susan Komorowski

October 27, 2009

- ~ Adopted Ordinance regarding private storm drain inlet retrofitting.
- ~ Introduced Ordinance to cover outdoor refuse containers and dumpsters exposed to stormwater for the prevention of spilling into municipal storm sewer systems.
- ~ Ordinance amendment was introduced regarding creation of the Municipal Court of North Hunterdon members must stay three years and pay 18% of operating taxes.
- ~ Additional changes made to Sign Ordinance—introduced same.
- ~ Councilwoman Valenta announced DOT Grant of \$163, 000 awarded for resurfacing Main and Lower Center Streets.

November 6, 2009

- ~Closure of Pony Truss Bridge to Main Street closed Nov. 16th for decking repairs.

November 24, 2009

- ~Adopted Ordinance requiring licenses for above-ground fuel storage tanks and dumpsters located in special flood hazard areas.
- ~Prior Ordinance amending Creating the Municipal Court withdrawn as further revisions needed.

- ~Town awarded \$140,000 grant for road improvements to Rachel Court.

December 8, 2009

- ~Resolution was adopted to lease/

purchase a police vehicle.

- ~Ribbon Cutting Ceremony for the new Open Cupboard Pantry December, 2009.

- ~Agway on West Main Street has closed.

- ~Discussion of strong Shared Services between the Town and Clinton Public School, is working together toward the Safe Routes to School Grant, school recycling projects, etc.

December 22, 2009

- ~Public discussion regarding Town Christmas Parade and attendees who save sidewalk space with chairs, interfering with access from parked cars. Solutions to be discussed further.

- ~ Resolution adopted to transfer Clinton Police Ford Pickup truck to Delaware Twp Police.

- ~Chief Brett Matheis was appointed Emergency Management Coordinator for a three-year-term.

- ~Solid Waste Advisory Council (SWAC) considering changes to recycling/trash pickup, possibly reducing trash pick-up to once per week, and increase recycling pick-up to once per week. The hope is to increase recycling by Town residents.

January 4, 2010 Reorganization Meeting

- ~The swearing in ceremony took place for Councilwoman Laurie Insel and Councilman Dan Shea

- ~Resolutions were adopted to appoint the Town Professionals for 2010.

- ~Mayor Schaumburg stated the Town had a great year with the help of a strong Council.

- ~The Town received many grants in 2009 and will continue to seek additional grants.

- ~Mayor Schaumburg announced the “Alley’s Way” project was done without any cost to taxpayers.

- ~Mayor Schaumburg remarked on the Town going “green”. We have applied for an energy audit.

January 12, 2010

- ~Budget meeting dates were discussed.

- ~A contract was awarded to QC Labs for laboratory services.

- ~Ordinance #01-10 was introduced to amend the land use regulating the installation of wireless telecommunications towers.

- ~Mr. Cutter reported the ice rink was assembled at Hunts Mill Park for the bonfire.

- ~Councilman Shea reported the bonfire will be held on January 23.

- ~Councilwoman Insel and Councilwoman Valenta will be applying for Open Space funds for the Gebhardt Field Grandstand.

- ~Councilman Duffy reported the Emergency Services is planning a basketball game with members of the Fire Department and Rescue Squad for April 9 at 7:00pm.

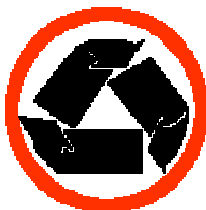
