# PLANNING BOARD

## **Master Plan Committee Update:**

Mr. Maher advised the board the Committee is finalizing a number of items on recommended changes to the Sign Ordinance and will be bringing them to the board at the December meeting for discussion. The Committee is also looking at other ordinances as it relates to flood issues and will report back to the board. Chairman Gallagher asked the committee to look into the noise ordinance, possible design standards for cell towers and satellite dishes.
