## **COMMUNITY CENTER & PLAYGROUND EQUIPMENT**

The members toured the playground equipment and the interior of the Community Center first floor. The following observations were noted and will be sent to Rich Phelan, PW Administrator and Art Dysart:

- 1. Several places on the big piece of equipment (with the bridge) it was noted that there was bare metal showing where the coating had worn away. It needs to be inspected for safety of the children.
- 2. The borders around the equipment and holding in the sand and the fibar are not in good condition some are higher in spots could cause a tripping problem
- 3. The fibar under the two swings needs to be raked deep holes under each swing.
- 4. The seat belt on the handicap swing should be checked.
- 5. The nuts and bolts on the diggers are rusted.

We are going to contact GameTime/Marturano, Burke and another company to have someone come out and give us an updated layout of equipment and prices.

Inside the gym we noted the following:

- 1. There is no screen over the middle/center light.
- 2. There is a hole in the shroud around the center light.
- 3. Broken window on right wall (outside court) near the closet under the stairs
- 4. Electrical outlet on left side of door to closet does not work nor does the light inside the closet.
- 5. Do you have bid specs for painting the gym? We would like to get quotes.
- 6. Question was asked about LED lights for the gym quotes?
- 7. In the kitchen the duct work has been pushed in can it be replaced?
- 8. Question was asked about air conditioning is it feasible, cost, etc.
- 9. Does the stove work, if not should it be replaced?
- 10. The bathrooms need work tiles cleaned, painting etc.
