#### CLINTON PUBLIC SCHOOL - BOARD OF EDUCATION

Richard Katz, Superintendent, and Lisa Kraft, Business Administrator, attended tonight's meeting to present the 2011-2012 Budget. Mr. Katz explained that 2010 was the first time their budget was defeated by the voters so they listened to the public, reviewed it closely and have now prepared a budget staying well under the 2% CAP. Mr. Katz distributed a packet to Council members and the public, outlining the proposal. Sharing services has proven to be a great way of saving money and the school board continues to explore additional opportunities to do so. Councilman Shea questioned Mr. Katz if Hampton Borough was ever approached to bring students in to Clinton? Mr. Katz had never considered that but will look into it.

Lisa Ayers addressed the Clinton-Glen Gardner merger, a new roof for the school to be done this summer, energy projects and shared services with Clinton Township.
