INTRODUCTION OF ORDINANCE #12-09 – AMENDING SIGN ORDINANCE

A motion was made by Mr. Smith, seconded by Mr. Pendergast, to adopt the introduction of Ordinance #12-09 on first reading as submitted:

ORDINANCE NO. 12-09

AN ORDINANCE REGARDING SIGNS IN THE PUBLIC RIGHT-OF-WAY AND THE DEFINITION OF SIGN ERECTION

WHEREAS, the Mayor and Council wish to clarify the procedure for permitting banner signs over public rights-of-way within the Town of Clinton; and

WHEREAS, the Mayor and Council also wish to clarify the definition of sign erection.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Town of Clinton, in the County of Hunterdon, State of New Jersey, as follows:

- Section 1. Section 88-64B(4)(i) is amended to read as follows:
 - (i) Signs in the public right-of-way, other than traffic control or warning signs, unless specifically permitted by the Mayor and Council for a public purpose in accordance with Article III of Chapter 122 of the Code of the Town of Clinton and meeting all the requirements herein.
- Section 2. Section 88-64R is amended by adding a new subsection to read as follows:

Signs in or over the public right-of-way as permitted by §88-64B(4)(i)

Section 3. Section 88-4A is amended by changing the definition for "Sign, Erection of" to read as follows

SIGN, ERECTION OF

To build, construct, attach, place, suspend or affix a sign, including the painting of wall signs and the painting of signs or displays on the exterior surface of a building or structure. A material change in any sign shall be considered as the erection of a new sign. A change in the wording of a sign shall not be considered a material change.

Section 4. Chapter 122 of the Code of the Town of Clinton is amended to add a new Article III as follows:

Article III. Signs In or Over the Public Right-of-Way

Section 122 Use of Roads, Streets and Sidewalks for Public Purpo
--

A. No signs of any type shall be placed in or over the public right-of-way except as permitted in Section 88-64 and this Chapter.

Section 122-___. Banners over Public Roads.

- A. The Mayor and Council may permit banner signs to be placed over the west end of East Main Street subject to the following conditions:
 - (1) Any organization wishing to erect a banner shall complete an application and file it with the Town Clerk at least 30 days prior to the date on which the sign will be erected.
 - (1) The size of the banner sign shall not be greater than 24 feet long and 4 feet high and shall have a square footage no larger than 96 square feet. Banners may be double sided. For double sided banners, only one face of the banner shall be counted in determining square footage.
 - (2) The banner may contain only the following information:
 - (a) The name of the organization.
 - (b) The name of the event.
 - (c) The date of the event.
 - (3) The banner sign shall only be installed by the Town of Clinton Fire Company which may charge a reasonable fee for installing the banner.
 - (4) Permission to locate a banner sign shall only be granted to charitable organizations located within the Town of Clinton or whose purpose is to serve the residents of the Town of Clinton.
- Section 5. Inconsistency. All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.
- Section 6. Severability. If any part, section, subsection, paragraph, subparagraph, sentence, phrase, clause, term, or word of this Ordinance is declared or held to be invalid or unconstitutional by any court of competent jurisdiction, such declaration or holding shall not affect any other part, section, subsection, paragraph, subparagraph, sentence, phrase, clause, term, or word of this Ordinance, even if such severability would result in less speech, whether by subjecting previously exempt signs to the permitting requirements of this Ordinance or otherwise.
- Section 7. Effective Date. This ordinance shall take effect immediately upon final passage and publication thereof according to law.
