HURRICANE SANDY DEBRIEF

Also being known as "Super Storm Sandy", Chief Matheis gave an overview of the preparations taken by the Police Department for the storm. Chief Matheis stated it was not necessary to activate the Emergency services, town was well managed and everyone was safe. When it was determined that seven wells were down and two were being run on generators, Chief Matheis went directly to the Fire Department to explain how this may impact fire suppression. Updates and information was constantly being distributed to residents via the clintonnjpolice.com website. Mr. Pendergast thanked the Chief and said he did an outstanding job! He then asked if it was necessary to declare an emergency, how long would it take to get assistance, Chief responded he would contact the county and assistance would be immediately forthcoming. Mr. Shea said the police website needs to be dovetailed to the town's website and the benefit of the police site is that it is managed and updated by the police.

Mr. Smith stated how important it is for everyone to call JCP&L and report outages. Mr. Duffy asked how many people can the reverse 911 reach, Chief responded they can only reach hard phone lines and so many people no longer have them or if power is out, they might not have phone signal. Chief also stated that past experience shows outages that occur on the far end of Center Street frequently and advised the property owner that they need to rectify the situation. Numerous substations were destroyed delaying repairs, Mr. Shea suggested the Town invite JCP&L to discuss what took place, however, he did state thanks were in order for their valiant effort to restore power as quickly as they did. Mrs. Insel reinforced how important it is for residents to sign up for the police website and the links to the Fire Dept and Rescue Squad Facebook pages, updates are made regularly.

Bucky Buchanan, Clinton First Aid and Rescue Squad, represented the Squad this evening and said preparations started two weeks prior to the storm. Bucky also reported on how the squad was staffed and how they responded to southern counties that needed help. RegisterReady.nj.gov is a valuable tool and urged residents, especially seniors to register. Hunterdon Helpline can offer assistance to people who need help in registering. People with special needs are strongly encouraged to register. Senior Advisor for the Town, Vince Cardarelli, will be asked to notify the seniors he has contact information for.

Scott Wintermute, Vice President of the Clinton Fire Department and Deputy Coordinator of OEM, attended tonight's meeting along with Deputy Chief Walt Dorf and Chief Steve Higgins. Scott reported the preparation efforts of the Fire Department and after thoughts on how the

department would approach another storm in the future. Walt Dorf said everything was well managed and with the large crew available, they were able to assist the road crew in clearing roads.

Carmine Iazzetta, 18 Goosetown Drive, suggested pre storm conference calls or group meetings to educate residents in case of evacuation, where shelters would be set up. Mr. Iazzetta did thank the squads and council for doing such a good job and keeping the residents informed.

Beth Sosidka, 1 Haver Farm Road and Councilwoman elect, described a mobile site, and mobile apps. that the schools seem to use to call households and keep families informed. Facebook is also a very good tool.

There being no further comments this evening, Mayor Kovach thanked the Fire Department and Rescue Squad and residents for coming.

A motion was made by Mr. Smith, seconded by Mrs. Insel, to adjourn the meeting at 8:55 p.m.
