County which Mr. Reisner presented to the council however the Town's records did not reflect this change. Judy Kopen, Town Attorney, looked at document and said the deed looks like it was sent back to Mr. Reisner's attorney after the recording. She then asked if the attorney forwarded a copy to the Town. Mr. Reiser confirmed that the document was sent to his attorney but could not recall if the attorney sent a copy to the Town. Mr. Reisner just became aware that he was still paying taxes for the two properties instead of one and presented the situation to the Town's Tax Assessor.
