#### PROPOSED WIND AND SOLAR ORDINANCE

valuable tool for the Town to have for solar panels on residential and commercial buildings and gave some guidelines for placement. Council members addressed the proposed ordinance and discussed changes to the proposal. Mayor Kovach asked Council to send suggestions to Board Secretary, Allison Witt, in order that she may prepare a list for her board members.

Public Comment - Carol Gallo, 25 Spruce Run Road, stated that her home faces due south and has panels on her roof. Ms. Gallo asked council to work with residents, not against.

Sheri Lieffig, 21 Haver Farm Road, explained to council that her home also faces south and she has had black solar panels for some time.

Chief Matheis updated Council of the pre-construction meeting held this afternoon regarding the Route 173 project that will run from Bloomsbury, to Bedminster and then back to Clinton. The milling and paving project should take 4-5 weeks and will be done during night time hours.

### Rich Phelan, PW/Business Administrator

1. Mr. Phelan reported that all current road and water projects are on schedule.

- 2. The Department of Public Works prepared the location for the Arbor Day celebration.
- 3. The Gebhardt Field Grandstand project is complete and looks fantastic!

#### Kathy Olsen, CFO

1. The annual Tax Sale is scheduled for 9:00 a.m. Wednesday morning, 12 properties are up for tax sale.

#### **Councilman Smith**

- 1. Mr. Smith The Water Committee reviewed the nine capital projects currently in various stages of completion. They discussed the water fluoridation with a consultant and if the bill is mandated, estimated costs are \$22,500 for fitting the well houses and an annual medium cost of \$18,000 a year for sodium. Mr. Shea suggested preparing a resolution and sending it to the State against the bill in light of the costs to municipalities. Mr. Smith agreed, now that we have estimated costs it may be a good idea to do so.
- 2. The Water Committee continues reviewing the unallocated water loss. New service meters to be installed into the ground were also addressed for new connections.
- 3. Every Thursday morning, the Water Committee meets with the contractors and the administrator to discuss project construction updates and organizing with each others construction schedules. Revisions are made accordingly to keep all projects moving along. Anticipated completion date is expected for mid to the end of June, 2012.

## **Councilman Shea**

- Roads Committee Projects continuing on Main, East Main and Lower Center Street with curbing and sidewalk replacement, pavers are now being installed. Mr. Shea commended the Roads and Water Departments for a fantastic job of road replacement on Leigh Street from Old 22 to Country Club Drive.
- 2. The State of New Jersey denied our grant request for the completion of the Leigh Street Project.
- 3. Following the Chief's update on the West Main Street construction project, Mr. Shea would like to notify Elizabethtown Gas Company so that the installation of gas lines can be arranged. Mayor Kovach said she and the administrator met with representative from the Gas Company and when scheduling is firm, will arrange a meeting with the residents of West Main.
- 4. Shade Tree Arbor Day is scheduled for 10:00 a.m. on Friday, April 27. A special surprise presentation will be made.

### **Attorney Cushing**

Mr. Cushing gave a brief history to council on the status of D & D Enterprises, LLC, located on West Main Street. In December, Attorney Walter Wilson and his client, Charles Didea, came before Council to request a temporary certificate of occupancy in order to occupy the commercial property on the first floor. Council authorized the property be granted the temporary certificate of occupancy with the condition that a bond be posted for the paving of the site. The bond was posted December, 2011. Mr. Didea and Mr. Wilson are now requesting a temporary certificate of

occupancy for the rental units on the second floor. There are two market rentals and two rental affordable housing units. Mr. Wilson has prepared the Deed for the affordable units and is ready to rent all units. Mr. Cushing explained that Council must authorize the construction official to issue the TCO.
