PRESENTATION BY THE NEW JERSEY DEPARTMENT OF AGRICULTURE

John Cambridge, Forest Pest Outreach Assistant Coordinator, asked to come before Council and residents to educate everyone about invasive forest pests that are coming into the United States inside solid wood packing material from China. In particular, Emerald Ash Borer and Asian Longhorned Beetle. Jeff Schaumburg, Environmental Chair and Pat Goehe, Shade Tree Chair, attended this evening's meeting to learn more about the forest pests. Emerald Ash Borer has already killed over 100 million trees in the US and it was only first found in 2002. NJDA is expecting to find it in New Jersey this year or next. The Asian Longhorned Beetle has already been found in New Jersey and they are working to ensure it causes as little damage as possible. Mr. Cambridge brought exhibits of bugs and the damage caused to trees and their barks. Fliers were distributed and follow up by the NJDA will be forthcoming. Residents are requested not to purchase firewood outside of a 15 mile radius to prevent these pests from coming into our area. Mr. Cambridge mentioned a northern Jersey town that is considering passing a resolution in support of the NJDA's request not to purchase firewood from outside of New Jersey. He will follow up with the Town and his supervisor, Paul Kurtz, will also follow up. A very interesting and well made presentation was given.

RESOLUTION CALLING FOR AN EXTENSION FOR AFFORDABLE HOUSING TRUST FUNDS TO BE COMMITTED

WHEREAS, P.L. 2008, c. 46 established a four year timetable for municipal housing trust dollars to be "committed for expenditure, or risk forfeiture to the State;" and

WHEREAS, the 2008 Act did not define the term "committed for expenditure" and deferred to the Council on Affordable Housing (COAH) to promulgate regulations as to be requirements to be met for "committed" as well as a timetable for expenditures; and

WHEREAS, neither COAH nor the Department of Community Affairs has adopted, nor proposed, the regulations pursuant PL 2008, c. 46; and

WHEREAS, hundreds of municipalities submitted spending plans to COAH, of which only a fraction of these plans were reviewed by the agency, and most of these municipalities have not been provided any guidance on their spending plans; and

WHEREAS, at the time of 2008 Act, COAH was prepared to adopt its "3rd round regulations" establishing municipal obligations under the "Fair Housing Act"; and

WHEREAS, COAH's 3rd round regulations were highly controversial and fundamentally flawed, and subsequently set aside by the Appellate Division, and the appeal of that decision now awaits consideration by the State Supreme Court; and

WHEREAS, eight years of litigation over COAH's methodology has had a chilling effect not only on the development of affordable housing, but on ability of local governments to commit trust funds dollars without knowledge of their respective obligations, and certainty that such commitment would count towards its housing obligation; and

WHEREAS, in 2008 the State Legislature passed the Permit Extension Act providing developers additional time because of the economic recess, an extension that was further granted in 2010 and which a third extension is now under consideration by the Legislature; and

WHEREAS, many of the projects in which the permits have been extended include an affordable housing component, and no such extension to municipalities; and

WHEREAS, forfeiture of trust fund dollars starting in July 2012 would be fundamentally unfair, inequitable and indefensible since neither COAH nor DCA has provided the required guidance or certainty; and

WHEREAS these trust fund dollars should be used as intended: to subsidize the costs for municipalities in meeting their affordable housing obligations while assuring that these costs do not fall to local taxpayers; and

WHEREAS, forfeiture of these dollars, estimated by some to be as much as \$200 million, would displace this financial obligation to the taxpayers in these communities; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Town of Clinton urges the Christie Administration and the State Legislature to extend the July 2012 to "commit" municipal affordable housing trust fund dollars and for the State to provide the needed regulatory guidance contemplated in PL 2008 c. 46; and

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to State Senator Michael J. Doherty, Assemblyman John DiMaio and Erik Peterson, the New Jersey State League of Municipalities and the Office of the Governor.

WHEREAS, the residents of the Town of Clinton are delighted to live in Hunterdon County. It is blessed with good roads, a strong agricultural heritage, good schools, a good transportation network, and the median household income is the fourth highest in the United States; and

WHEREAS, however, the demographics of the County are shifting. Its population in 1970 was 60,718; its population in 2010 was 128,314, a 54 percent increase over 40 years; and

WHEREAS, as population has increased so has the amount of criminal activity; and

WHEREAS, in the past few months, there has been a tremendous spike in the number of burglaries throughout the County; and

WHEREAS, there has also been a substantial increase in diversification in the County with the number of non-English speaking residents increasing which has increased the challenge of providing those communities with protection from criminal activity; and

WHEREAS, although unheard of in the past, sporadic incidents of gang related activity have shown up from time to time; and

WHEREAS, a number of municipalities in the County have no police department or very small police departments; and

WHEREAS, the challenge from criminal activities associated with illicit drugs, gangs, domestic violence, violent activity and property crimes is increasing to some degree as a result of the difficult economic times; and

WHEREAS, the Hunterdon County Prosecutor's Office is responsible for the reasonable and lawful detection, arrest, indictment and conviction of those who violate the laws of the State of New Jersey; and

WHEREAS, the enviable life style enjoyed by the citizens of Hunterdon County requires that criminals be immediately apprehended and punished so that others will be discouraged from committing crimes in Hunterdon County or elsewhere; and

WHEREAS, the ability of the Hunterdon County Prosecutor's Office to protect, arrest, indict and convict those who violate the criminal laws of the State of New Jersey is a function of the amount of resources which the Prosecutor's Office has at its disposal to carry out its vital functions; and

WHEREAS, the Hunterdon County Prosecutor's Office has determined it needs additional resources in order to be able to adequately combat criminal and gang activity and has need for non-English speaking staff who can reach out to communities in the County which are non-English speaking in order to be able to safely protect those communities and to assist those within them who have been the victims of crimes; and

WHEREAS, the economic and social fabric of Hunterdon County would be challenged, if criminal activity is permitted to increase and there is not adequate means to combat it; and

WHEREAS, the Town of Clinton supports the efforts of Prosecutor Kearns to maintain and develop the professional standards of the Prosecutor's Office and to expand its operations so as to be able to stymie any criminal threat to the desirable life style and economic well-being of Hunterdon County.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Town of Clinton, Hunterdon County, New Jersey, as follows:

- 1. The Town of Clinton expresses its full support for the efforts of Prosecutor Anthony P. Kearns, III to professionalize and strengthen his office so as to be able to effectively respond to whatever criminal activities may occur in Hunterdon County.
- 2. The Mayor and Council encourage the Hunterdon County Freeholders to provide all necessary financial support to the Hunterdon County Prosecutor so that he may have the resources necessary to counteract any threats of or criminal activities which occur in Hunterdon County
- 3. While the Mayor and Council of the Town of Clinton are not in favor of seeing the County increase taxes, they support a reasonable increase in taxes to combat

- criminal activities which may threaten the County youth, senior citizens, its life style and economic prosperity.

disclosure of such information at this time would have a potentially negative impact on the municipality's position with respect to the matter being discussed; therefore this information will be withheld until such time as the matter is concluded or the potential for negative impact no longer exists);
Matters involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance, promotion or disciplining of any specific prospective or current public officer or employee of the public body, where all individual employees or appointees whose rights could be adversely affected have not requested in writing that the matter(s) be discussed at a public meeting; (The employee(s) and/or general nature of discussion is

OR the public disclosure of such information at this time would violate the employee(s) privacy rights; therefore this information will be withheld until such time as
the matter is concluded or the threat to privacy rights no longer exists.;
Deliberation occurring after a public hearing that may result in the imposition of a specific civil penalty or loss of a license or permit;
BE IT FURTHER RESOLVED that the Mayor and Council hereby declare that their discussion of the subject(s) identified above may be made public at a time when the Town Attorney advises them that the disclosure of the discussion will not detrimentally affect any right, interest or duty of the Town or any other entity with respect to said discussion.
