PUBLIC COMMENT

Julie Trepkau, 5 Union Road, questioned the Council about the Facebook postings of dead trees on East Main Street and if there are potential dangers with some of the weak and diseased trees in Town. Mr. Phelan explained that the Shade Tree has a maintenance list and periodically tours the Town with the Arborist, Lou Spanner. Public Works also checks on trees and responds to phone calls from residents that notify the Town if there is a situation to be examined. The Shade Tree is currently working on a plan to address a few trees in Town. Mrs. Trepkau said that Girl Scout troops were being asked to raise money to help remove the dead East Main Street tree and have it replaced. Mrs. Insel noticed a tree past the Clinton House, on the right side along the river, that need to be checked. Mr. Phelan said when calls come in, the Shade Tree accesses the tree, determines whether it is the homeowners or a town tree, and then it is either trimmed or taken down by the appropriate party. Mr. Cushing said if anyone sees a tree that is compromised, please call the Public Works Department. The Shade Tree Commission has an inventory of trees and it can be quickly determined whose responsibility it is.

Walter Hetzel, 36 West Main Street, is encouraging Council to notify the Web site, newspapers and residents to spread the word that volunteers are needed on the Board of Adjustment.

Peter Grantham, 34A Main Street, suggested placing a description of the volunteer positions available for interested parties to know meetings schedules and what would be required.
