# RESOLUTION AUTHORIZING LOCATION OF COLLECTION BOXES IN MUNICIPAL BUILDING FOR COLLECTION OF DONATED ITEMS BY NOT-FOR-PROFIT ORGANIZATIONS

**WHEREAS**, various not-for-profit organizations have requested the right to put collection boxes in the municipal building; and

**WHEREAS**, the Mayor and Council wish to establish a uniform policy permitting and regulating the location of collection boxes in the municipal building.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Town of Clinton, Hunterdon County, New Jersey, that collection boxes may be located in the municipal building under the terms and conditions described as follows:

- 1. Any not-for-profit corporation or organization, recognized as a not-for-profit pursuant to 501(C)(3) of the Internal Revenue Code ("not-for-profit"), may apply to the Municipal Clerk for location of a collection box in accordance with the terms of this Resolution.
- 2. The collection box may only be located inside the easterly entrance to the municipal building at a place designated by the Municipal Clerk.
- 3. The collection box shall not exceed 2 feet wide, 2 feet high and 4 feet long and shall be neat and sturdy enough to collect the items sought. Only non perishable items may be collected. Requests for the collection of items that may attract vermin at the discretion of the Clerk, may be denied. For reasons of lack of

- security in the area designated for collection, no boxes for collection of money are permitted.
- 4. A collection box may only be located in the municipal building for a 30-day periods. A qualifying not-for-profit may request one or more additional 30-day period, providing that no other qualifying not-for-profit has sought to locate a box for the same time period requested. Any requests to locate a collection box shall be handled on a first-come first-served basis.
- 5. The only identification that may be placed on the box is the name of the organization, the purpose of the collection and name and a telephone number of a contact person.
- 6. The not-for-profit that seeks to locate a collection box shall supply the Municipal Clerk with the name and address of a representative of the organization who can be contacted to remove collected items, police the area around the box and remove it at the end of the approved time period.
- 7. The not-for-profit shall be responsible to police the area around the collection box and remove any debris, trash or garbage from the box and the surrounding area.
- 8. The Municipal Clerk is authorized to create an application form for the location of a collection box and to approve all applications that meet the requirements of this resolution.

Upon returning to the regular meeting, the public also returned. In response to Ms. Wetherill's question, Mr. Cushing reported that "at the last meeting we were able to report that we had an agreement that was agreeable to the town and that we thought was agreeable to the museum. However, the museum had complaints about the timing. We had additional discussions with the museum attorneys and we now have a completed agreement with the museum and expect that within the next 4 or 5 days, the agreement will be signed and inked. We hope to see the process moving ahead and the next step is for the museum to apply for a minor site plan or a waiver of site plan. The museum did submit an application to the Planning Board and it is now being reviewed and the Planning Board will be hearing testimony necessary in connection with the application. The museum will be delivering a mortgage to the Town to secure the commitment for the loans by August 12. If the museum does not get approval from the Planning Board they can void the agreement. The agreement as to the amount owed the Town is \$179,947.73 and we

have worked it out to resolve the problem and move forward to get the museum patio built for them and to reimburse the residents of the Town of Clinton for the money that has been put forth by the Town already." Mr. Smith said he hopes to see a signed copy of the agreement soon. Walter Hetzel asked how many changes were in the agreement and Mr. Cushing stated that he is having a meeting and working out the final language issues.
