RESOLUTION RESCINDING AUTHORIZING THE ACCEPTANCE OF THE FEDERAL SAFE ROUTES TO SCHOOLS GRANT

WHEREAS, on April 8, 2008 that Town of Clinton (Town) authorized the submission of a grant application to the New Jersey Department of Transportation (NJDOT) for funding under the Federal Highway Administration's Safe Routes to Schools Grant (SRTS), and

WHEREAS, the main objectives of the grant were as follows:

• To enable and encourage children in grades K-8, including those with disabilities, to walk and bicycle to school;

- To make bicycling and walking to school a safer and more appealing transportation alternative, thereby encouraging a healthy and active lifestyle from an early age; and,
- To facilitate the planning, development and implementation of projects and activities that will improve safety and reduce traffic, fuel consumption and air pollution in the vicinity of schools.

WHEREAS, on December 18, 2008, the Town received notification from the NJDOT that we received a grant in the amount of \$225,000 as part of the SRTS program, and

WHEREAS, due to Federal regulations, even though the Town was the recipient of the grant, the grant itself had to be overseen and administered by the NJDOT, Division of Local Aid, District 3; and

WHEREAS, during the last six (6) years, there have been countless rule/procedure changes mandated by the NJDOT, to which the Town complied with in good faith in order to move this project forward; and

WHEREAS, the Town felt that every forward step we took resulted in us taking two steps backwards resulting in hardships being placed on the Town by the NJDOT's inability to effectively work through the Federal funding requirements; and

WHEREAS, as a result of the afore-mentioned hardships, the original requirements of this grant have been modified to such an extent that it is no longer practical for Town to proceed forward with this project.

THEREFORE, BE IT RESOLVED, that the Town of Clinton hereby rescinds our desire and interest in this grant opportunity.

BE IT FURTHER RESOLVED, a copy of the resolution be forwarded to the New Jersey Department of Transportation (Division of Local Aid, District 3), Hunterdon Area Rural Transit (HART), Town of Clinton Municipal Engineer, Senator Michael Doherty, Assemblyman John DiMaio and Assemblyman Erik Peterson.
