Paige McGaheran, daughter in law of Allie and Pat McGaheran, accepted the proclamation from Congressman Lance and the American flag that was flown over the Capitol in honor of Allie. Paige's eloquent acceptance speech praised Allie and Pat McGaheran and joked that Allie would have asked "what's all the fuss about?!" Paige spoke in their honor and the irony of accepting it on the day that Pat McGaheran was laid to rest and that afternoon, Allie passed away. As was Allie's wish, "she said she didn't know how she would live without him". Beautiful.

The second surprise was to a long time and current councilman who also served as Mayor from 1974 to 1983. Congressman Lance presented the next proclamation and American flag to his long time friend, Robert B. Smith! His wife, Nancy, was called to the front to accept recognition along with her husband. Of course, "behind every good man is a good woman!"

A round of applause to the two recipients, well deserved. Before Congressman Lance ran off to another re-organization meeting in Union County, he wished the Town a successful 150th anniversary and the keepsake calendar will be placed in his office in Washington, D.C.!
