On Monday, January 26, 2009, Mayor Schaumburg's house suffered extensive damage to the second floor bathroom and entire attic. Thankfully, the family and pets are safe.

HIGHLANDS PRESENTATION

Lisa Specca, P.P. of Clarke, Caton & Hintz, gave a descriptive overview of what the Highlands Council is expecting from municipalities for Plan Conformance and the Initial Assessment. Ms. Specca provided maps which depicted Highlands sub zones, such as Steep Slopes and the Riparian Area (water ways); areas of the Town which are built out and areas of potential building. The Plan Conformance Grant will provide funding to Towns for professional costs, to proceed with a Build-Out Analysis Module and Plan Conformance to be submitted by December 8, 2009. For the Initial Assessment, Towns are to review the maps and identify errors, bringing information to light to the Highlands Council.

Ms. Specca asked for Council's authorization to move ahead with submitting the Highlands Initial Assessment and factual verifications of the Town which is to be submitted by February 27, 2009.
