- 2. Eugene De Cleene, Emergency Services Foundation, announced that the Foundation is selling raffle tickets and the drawing will be held during the Towne Restaurant's Celebration.

PROCLAMATION:

Mayor Schaumburg read the Proclamation congratulating the Rentoulis Family on 30 wonderful years and wishing them many more years of success in the Town of Clinton.

3. Attorney Walter Wilson introduced himself and Jim Chmielak, P.E., Engineering and Land Planning Assoc. They are working on behalf of Philip Barretti with respect to the former Moebus Tract, Block 14, Lot 32, and have previously met and presented plans to the Planning Board.

They understand that the most optimum use of the property, from the Town's perspective, might be a park. The other end of that spectrum might be a big box commercial development and somewhere in between is a reasonable application of reality to the land. They have done an analysis from the developer's side of what and what doesn't work; trying to take into account the interests of the Town as well. Their preliminary presentation to the Planning Board was a residential development with a mix of single family and detached units, some of which would be affordable housing. They feel that the use of office or retail components would not be appropriate at this time.

Mr. Chmielak displayed and described a residential concept sketch showing 60 units with proposed access from a continuation of Fairview Avenue at the intersection of Georges Place.

Mr. Wilson stated they are working on a fiscal impact analysis for the use of the property. Mayor Schaumburg asked that they include in the analysis larger lot sizes with larger homes, which would suit this property and fill a void in housing that we have here. This would have less of an impact on our crowed school situation. The affordable attached units should be included as well.

Mr. Cutter asked if they would consider intermingling, instead of segregating, the affordable housing units with the single family homes. Mr. Wilson replied that the segregating aspect doesn't work too well and they may be able to do a combination.

MAYOR'S COMMENTS

1. At the May 5, 2009 Planning Board Meeting the Board recommended the following recommendations to Mayor and Council:

Amend Section 88-64 N. of the Sign Ordinance, which reads "Standing Signs shall require a license issued by the Town Council" and replace with "Standing signs shall require a license issued by Town of Clinton Zoning Office".

Council agreed that this be given to the Town's attorney to prepare the amendment for introduction at the May 26, 2009 Council Meeting.

- 2. The Police Committee met last week with Chief Matheis regarding shared police services and police consolidation and specifically discussed the proposal for shared services from Lebanon Borough. The Committee decided that at this time it was not financially feasible and the Chief has responded to Lebanon Borough advising them of this. The Committee is not closing the door at this time to discussions about other police shared services.
- 3. Mayor thanked Councilwoman Insel for working on the Highlands Grant. The Town has received \$50,000. to work on Modules 2 and 3.
- 4. Mayor attended the N J Conference of Mayors last week. She appeared on NJN and attended many good sessions at the conference. She would like to see more information coming from the

State on the Federal Stimulus Package. She has been appointed to the Conference of Mayors Executive Board and is a Vice President and a Treasurer. She will be testifying before our Legislature on a regular basis and working on our behalf.

5. PROCLAMATION – EMERGENCY SERVICES WEEK:

The Mayor read the Proclamation proclaiming the week of May 17 - 23, 2009 as Emergency Medical Services Week recognizing the value and accomplishments of emergency medical services providers.

SPECIAL EVENT – RENASSIANCE FESTIVAL

Council is receipt of the recommendations and requirements from Chief Matheis for the Festival to be held on the consecutive weekends of June 20-21 and June 27-28, 2009 from 12 Noon to 7:00 p.m. This is a renaissance and medieval entertainment event with demonstrations, activities, shows, music, and children's games. The Chief will be reassessing the event following the first day, in the event any changes in requirements, especially the contracting of off-duty police officers, need to be made.
