EXCEPTIONS

A. DOGS USED AS GUIDES FOR BLIND PERSONS AND COMMONLY KNOWN AS SEEING EYE DOGS SHALL BE LICENSED IN THE SAME MANNER AS OTHER DOGS, EXCEPT THAT THE OWNER OR KEEPER SHALL NOT BE REQUIRED TO PAY ANY FEE.

- 2. ALL DOG AND CAT LICENSES EXPIRE ON DECEMBER 31ST EACH YEAR.
- 3. CHECK RABIES INFORMATION AND NEUTER STATUS
- 4. NO DOGS ARE PERMITTED TO RUN AT LARGE. OWNERS WILL BE SUBJECT TO A FINE,
- 5. LICENSE MUST BE ISSUED IN THE NAME OF AN ADULT MEMBER OF THE HOUSEHOLD.
- 6. FREE RABIES CLINIC- IN JANUARY
