Minutes of the Town of Clinton Land Use Board meeting held on September 5, 2017 at 7:00pm in the Municipal Building at 43 Leigh Street Clinton, New Jersey 08809

Chairman Sailer called the meeting to order at 7:00pm and read the "Statement of Adequate Notice" and the "Administrative Statement".

Site Plan Review Report:

Mr. Feldmann, Mr. Maher, Mr. Smith met to review a Minor Subdivision application submitted by SNG Properties LLC, the submission included a Minor Subdivision Plan application, Far Variance, Lot Area Variance and Sign Variance. The applicant has also submitted a concept plan which is not part of the application but will be used to show the board the proposed use of the new lot if the subdivision is granted. The committee stated the Minor Subdivision was missing item # 12 off the checklist and recommended the board deem the application complete conditioned upon the submission of item # 12 only if Mr. Clerico found is necessary during his review.

Board Discussion:

Mayor Kovach gave the board a brief update on COAH and the pending litigation, she advised the board the possible redevelopment areas within the town will give us affordable housing opportunities. Mayor Kovach stated we are moving forward with the affordable housing commitment we are just waiting for the courts final decision on the number of units the Town will have to provide.

Mayor Kovach advised the board that she has been working with the county in gaining funding to streamline the process to help businesses come and stay in town which will bring jobs to the area and be attractive to homebuyers in Clinton. The town is in the process of putting together an Economic Development Committee which will be headed by Councilwomen Sherry Dineen.

Mr. Carberry advised the board the Town is working with DOT in putting in sidewalks along Old Hwy 22 which will give the area more of a connection into town.

Mr. Carberry stated he felt the sign ordinance was cumbersome and asked the board to look at sign ordinance as part of the Master Plan review.
