#### **Board Discussion:**

The board received a copy of the Governing Body's Resolution # 60-18 requesting the Land Use Board look at a section of town to determine if it meets the redevelopment criteria.

A Motion was made by Mr. Carberry, seconded by Mr. Viotto, to authorize Jim Kyle to prepare a preliminary investigation study for the Land Use Board to determine if the block and lots outlined in Resolution # 60-18 is in an area that meets the criteria as an area which is in need of redevelopment.

#### All Ayes: Motion carried.

Mr. Carberry advised the board that he was advised by the Board Attorney that he was not able to discuss any issues pertaining to the Moebus Tract for two reasons; one being he lived within 200 feet of the development and second he was involved with a group of concerned residents regarding the development of the Moebus Tract. Mr. Carberry stated because a portion of the land will be deeded to the town his property no longer falls within 200 feet of the Moebus Tract and he had been advised by Council to no longer participate in the group. The group is investigating buying the residential portion of the property. Mr. Carberry stated he just wanted to make clear what his involvement was. Chairman Sailer commented that the issue was his involvement with the group and being a voting Land Use Board member.
